

ARTICLES OF INCORPORATION

BANGS CHURCH OF CHRIST

WE, THE UNDERSIGNED NATURAL PERSONS, at least two of whom are citizens of the State of Texas, and who are of the age of eighteen (18) years or more, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME

The name of the corporation is the BANGS CHURCH OF CHRIST.

ARTICLE TWO

NON-PROFIT CORPORATION

The corporation is a non-profit corporation.

ARTICLE THREE

DURATION

The period of its duration is perpetual.

ARTICLE FOUR

PURPOSES

The purposes for which the corporation is organized are:

To glorify God, provide fellowship for the family of Christ, care for those in need, and spread the gospel of salvation through Christ throughout the world, in accordance with the teachings of the Holy Bible.

Notwithstanding any of the above statements of purposes or powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

This corporation is organized pursuant to the Texas Non-Profit Corporation Act and does not contemplate pecuniary gain or profit and is organized for non-profit purposes.

#### ARTICLE FIVE

##### INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 502 Goodwin, Bangs, Texas and the name of its initial registered agent at such address is Don Early.

#### ARTICLE SIX

##### BOARD OF TRUSTEES

The number of trustees constituting the initial Board of Trustees of the corporation is three, and the names and addresses of the persons who are to serve as the initial trustees are:

ARTICLE EIGHT

ADDITIONAL PROVISIONS

1. The membership of the corporation shall be non-voting. All matters concerning corporation management, including the acquisition of property, the disposition of property, and the use of church property shall be made by the Board of Trustees.

2. The Board of Trustees shall be synonymous with the eldership of the Bangs Church of Christ. A man shall become a trustee of the corporation upon selection as an elder for the Bangs Church of Christ, and shall remain in that capacity for the duration of his service as an elder of the Church.
