Good afternoon, Rick.

The letter digital notification that you recently submitted to the Commission via US Mail on behalf of station licensee, Hochman Hawaii One, Inc., has arrived and I have one question. I calculate from the TPO data contained in the letter that Station KTOH(FM) will be operating its hybrid digital facilities with -14 dBc digital ERP. However, since the letter did not specifically state the digital ERP, I felt that I should verify before entering the data into CDBS.

For your future reference, digital notifications for FM stations using digital ERP up to and including -14 dBc should be electronically filed using FCC Form 335 available in CDBS Informal Filings.

Thank you in advance for confirming the Station KTOH(FM) digital ERP.
