

DECLARATION OF TONY CUELLAR

I, Tony Cuellar, make the following Declaration under penalty of perjury.

I was the high bidder for the Eldorado, Texas FM channel at FCC Auction 93. I filed an application for that facility with the Federal Communications Commission on May 29, 2012. When I was completing my application, I was not sure as to whether I had a legal obligation to provide information to the FCC regarding my prior criminal conviction, which I considered to have occurred in the distant past, and so I discussed the matter with counsel, who I had just retained. I completed and filed my FCC application and filed an amendment based on my understanding of FCC policy and my discussions with counsel.


My conviction occurred 14 years ago for conduct occurring 16 or more years ago. At the time of my conviction, I was a completely different person than I am today. Frankly, I am not proud of some of the things that I did when I was a young man. However, I have attempted since my release from incarceration in 2001 to live a model life and to be a hard-working person of good character. I have remarried and my wife and I own and operate a business, T.C. Trucking & Construction, LLC.

I have endeavored to lead a good life for the past 11 years and give back to the community. That is the reason that I wish to operate a broadcast station, in order to provide a public service to my local community. Since 2001 when I was released from incarceration, I have not been involved in any nefarious or illegal activity. I have not been arrested for anything. I have operated my business since 2006 and have had an ongoing business relationship with the First Financial Bank of San Angelo since that time. Also, T.C. Trucking & Construction business is certified as a Disadvantaged

Business Enterprise Program entity under federal regulations and my business is considered to be a Historical Underutilized Business under Texas State law. T.C. Trucking & Construction has been involved in three federal aid projects including the federal stimulus program, in which the participation of T.C. Trucking & Construction has counted toward the assigned contract Disadvantaged Business Enterprise Program goal. I am attaching commitment worksheet information pertaining to those three projects.

As noted, since 2001, I have sought to live my life in a positive way and serve my community in a meaningful manner. I would appreciate it greatly if the FCC would allow me to serve the public interest by granting my current application. I believe that individuals can change and that what a person does in his relative youth does not and should not disqualify him from serving the public in the future.

The information contained in the attached Supplemental Response is true and correct to the best of my knowledge and this Declaration is true and correct to the best of my knowledge and belief.



HISPANICS OF INFLUENCE: Daniel Cardenas

SAN ANGELO, Texas —Outside a house under construction near Van Buren Street, Daniel Cardenas spoke to a middle-aged man in Spanish. He had popped up at the door while Cardenas was inside preparing for several hours of work on the house for a woman who had lost her uninsured home in a fire.

The man explained that he hadn't had work in months and wanted to know if Cardenas had any construction help needs or knew of anyone who did. Cardenas wrote his information on a scrap of yellow paper, and put the paper in his pocket.

"I'm very spirited," Cardenas said. "I want to get things done."

His dynamism has led the 57-year-old businessman, who owns the monument business A-Angel Memorial, to spend many years in San Angelo's political arena. He is one of the most prominent Hispanic activists in San Angelo.

He was on the San Angelo City Council for 12 years beginning in the 1980s, on the city of San Angelo Zoning Board of Adjustments for six years and on the San Angelo Independent School District board of trustees for three years.

He counts getting artificial turf for SAISD, starting a low-income housing program, getting water meters installed and making Angelo State University's Carr Scholarship Academic Scholarship focus on needy students among his accomplishments.

He has fought for other elected positions as well, most recently for Precinct 1 County Commissioner, which he lost to Ralph Hoelscher.

He switched from Democrat to Republican, and he also plans to try again and run for Precinct 1 County Commissioner.

Cardenas knows he has been the subject of controversy, and he says he is a politician willing to stand alone for what he believes.

"He had a real strong sense of responsibility to represent people in his district," said Tim Edwards, a San Angelo attorney who has been mayor and served with Cardenas on the City Council. "Sometimes that involved taking an unpopular stance."

Cardenas still maintains a cordial relationship with Edwards whenever the two happen to meet around town, Edwards said.

"He has his admirers and his detractors, and people in each group feel strongly," Edwards said.

In the area of principles, Cardenas' motto continues to be: "What's popular is not always right, and what's right is not always popular."

Born in Eldorado, Cardenas was raised in San Angelo and has lived in the city all his adult life. Although he has been portrayed as primarily looking out for Hispanics, he said he wants to help all who are needy.

"I'm for everyone I feel are underprivileged," Cardenas said. "I carry on the heritage of being an American and a proud American. To me, being Hispanic is secondary. I'm very proud of my heritage, but I cannot dwell on it."

He hopes that the younger generation will emulate his attitude of getting things done and not sitting back.

He wants people to be prepared, to do the research and to be proactive in bringing about change.

"Nothing has brought change or been accomplished without fighting and standing up for change. I want people, especially the young generation, to bring change themselves, to make the community a better place to live," Cardenas said. "They cannot sit back and be spectators."


