This is in reference to your filing of January 15, 2014, on behalf of the University of Chicago ("UC"). UC previously advised that the building on which WHPK-FM's licensed antenna had been located (Pierce Hall), was to be demolished in August 2013. A previous STA (BSTA-20130717AIK) for temporary facilities was granted July 29, 2013. WHPK-FM holds construction permit BPED-20130618ABI for a permanent installation, however those facilities have not yet been constructed. Until that time, UC requests an extension of the July 29, 2013 STA.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Extension of the July 29, 2013 is warranted, and the STA extension is **IS HEREBY GRANTED**. WHPK-FM may continue to operate with the following temporary facilities:

Location:	3.3 meter pole, atop 6031 South Ellis Avenue.

We expect that broadcast operations from this facility will be maintained through the term of this STA request. Extensions may be requested and approved, provided the request demonstrates continued progress toward resuming licensed operation. UC must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.
