This engineering statement has been prepared on behalf of Nexstar Broadcasting, Inc. (“Nexstar”), licensee of WJET-TV, Erie, Pennsylvania. The purpose of this engineering statement is to amend the initial request for license to cover the outstanding construction permit (FCC File No. BMPCDT-20080612ABV) for digital television (“DTV”) facilities and to supplement those data required in FCC Form 301, Section III-D. This amendment corrects the erroneously reported 10.866 dB antenna gain to 16.866 dB to reflect the antenna manufacturer’s data.

WJET-TV operated on NTSC Television Channel 24 with a maximum visual horizontal effective radiated power (“ERP”) of 1120 kW directional and a height above average terrain (“HAAT”) of 290 meters. WJET-TV has been allocated post-transition DTV Channel 24 with facilities of 523 kW maximum directional ERP and HAAT of 310 meters in the Final DTV Table of Allotments.¹ WJET-DT has been authorized and has constructed DTV facilities on its post-transition Channel 24 with 523 kW directional ERP (horizontal polarization) at an HAAT of 304 meters at the existing WJET-TV tower site and requests a license herein to operate pursuant to these authorized facilities (FCC File No. BMPCDT-20080612ABV).

The post-transition DTV antenna has been top-mounted on the existing tower having a total overall structure height above ground of 248.9 meters (817 feet). The existing transmitter site is located at 8455 Peach Street, Erie, Pennsylvania.

The antenna structure registration number (“ASRN”) of the existing tower is 1033280. The geographic coordinates are:

Special Operation Condition

Nexstar acknowledges that the grant of this DTV license is subject to the special operation condition specified in the outstanding construction permit. Therefore, Nexstar certifies that it has made a good faith effort to identify and notify health care facilities (e.g., hospitals, nursing homes, see 47 CFR 15.242(a)(1)) within the WJET-DT service area potentially affected by these authorized DTV operations. During this pre-broadcast period, Nexstar provided all notified entities with relevant technical details of its authorized operation of WJET-DT, such as DTV channel, targeted on-air date, effective radiated power, antenna location, and antenna height. Documentation of the notifications and contacts made have been placed in the station's public inspection file. During this pre-broadcast period and for up to twenty (20) days after commencing operations, should Nexstar become aware of any instances of medical devices malfunctioning or that such that devices are likely to malfunction due to the WJET-DT operations, it shall cooperate with the health care facility so that it is afforded a reasonable opportunity to resolve the interference problem.
