ENGINEERING STATEMENT

PURPOSE AND SCOPE

This Engineering Statement has been prepared on behalf of Mariner Broadcasting, L.P.("Mariner"), assignee of FM broadcast station WBYA(FM), Islesboro, ME. This Statement addresses the overlap of the City Grade contours of WBYA(FM) and other stations owned by Mariner.

AFFILIATED STATIONS

Mariner owns five FM broadcast stations in addition to WBYA(FM). Those facilities are:

CITY GRADE OVERLAPS

As shown on the attached Figure 1, the WBQX(FM) 70 dBu F(50,50) contour overlaps in part the WBYA(FM) 70 dBu F(50,50) contour. No other 70 dBu contour from a Mariner owned facility overlaps the WBYA(FM) 70 dBu contour.

STATIONS IN MARKETS

Plotted on Figure 1 of this Statement are the transmitter sites and, where required, the 70 dBu F(50,50) contours of some of the stations located within the market defined by the WBQX(FM) and WBYA(FM) 70 dBu contours.

As shown in Figure 1, at a minimum, the following six stations have transmitter sites within, or have 70 dBu contours that overlap, in part, the WBQX(FM) 70 dBu contour.

CONCLUSIONS

Common ownership of WBQX(FM) and WBYA(FM) is permissible under 47 C.F.R. § 73.3555(a)(1)(iv) in that those two stations represent less than fifty percent of the stations in the market.
