

## **EXHIBIT 5**

### **OTHER AUTHORIZATIONS IN WHICH WBOY-TV, L.L.C. HAS AN ATTRIBUTABLE INTEREST**

WBOY-TV, L.L.C. is a wholly owned subsidiary of Hearst-Argyle Properties, Inc., a wholly owned subsidiary of Hearst-Argyle Television, Inc. Hearst-Argyle Television, Inc. is a majority owned subsidiary of Hearst Broadcasting, Inc, a wholly owned subsidiary of Hearst Holdings, Inc., a wholly owned subsidiary of The Hearst Corporation.

#### **The Hearst Corporation**

The Hearst Corporation ("Hearst") is not a broadcast licensee. However, Hearst does have a time brokerage agreement with KCWE-TV, Inc. to operate Station KCWE (TV), Kansas City, Missouri (Facility ID # 64444).

Frank A. Bennack, Jr., President, CEO, and Director of Hearst, is a member of the Board of Directors of J.P. Morgan Chase & Co. Hearst is unaware of any J.P. Morgan Chase & Co. investments which would implicate the FCC's multiple ownership rules.

In any event, Mr. Bennack has previously pledged to recuse himself from participating in any decision as a J.P. Morgan Chase & Co. director which would place him in a position that would contravene the Commission's multiple ownership rules (See FCC File Nos. BALCT-980226IA; BALCT-980226IE and BALCT-980226IF). An attribution exemption has been granted by the Commission.

#### **Hearst Holdings, Inc.**

Hearst owns 100% of Hearst Holdings, Inc. Hearst Holdings, Inc. is not a broadcast licensee.

#### **Hearst Broadcasting, Inc.**

Hearst Holdings, Inc. owns 100% of Hearst Broadcasting, Inc. ("HBI"). HBI is not a broadcast licensee. HBI owns 100% of each broadcast licensee of the following stations:
