NM Licensing LLC is an indirect subsidiary of NextMedia Investors LLC. NextMedia Investors LLC owns all of the capital stock of NextMedia Group, Inc. which owns all of the capital stock of NextMedia Operating, Inc. NextMedia Operating, Inc., in turn, owns all of the membership interests of NM Licensing LLC. NextMedia Investors LLC, itself, is controlled by its board of directors except that, under limited circumstances, certain matters may require both Board approval and a vote of "Special Majority of the Members," which includes the TWP Members, the Weston Presidio Members, the Goldman Sachs Members, the Alta Members and any other Class A Member serving on the Board of Directors.¹

A chart generally depicting the chain of ownership and control of NM Licensing LLC is included as Exhibit 11B to this application.

Equity/debt plus attribution plays no role in the ownership structure of NextMedia Investors LLC and its subsidiaries. As of May 31, 2005, the consolidated companies have approximately \$555,367,879.00 in total assets and approximately \$255,000,000.00 total debt. The debt is in the form of \$200,000,000.00 publicly traded debt securities and bank loans totaling \$55,000,000.00. No individual or entity holds sufficient amounts of these debt securities to convert an otherwise unattributable interest in NextMedia Investors LLC or its subsidiaries into an attributable interest under the equity/debt plus standards.

NextMedia Investors LLC is a board of directors-managed limited liability company and ownership interests in NextMedia Investors LLC do not correspond directly with power to influence the operation of NextMedia Investors LLC's media interests. The Second Amended and Restated Limited Liability Company Agreement of NextMedia Investors LLC, as amended, (the "LLC Agreement") vests management of NextMedia Investors LLC in its board of directors (the "Board"). See LLC Agreement at para. 6.1(a). Certain Class A Members of NextMedia Investors LLC have the

power to elect members of the Board (“Board Members”) in the manner set out in paragraph 6.2 of the LLC Agreement. Apart from this power to elect Board Members, paragraphs 6.11 and 8.6(a) of the LLC Agreement act in combination to place most matters affecting the day-to-day operation of NextMedia Investors LLC in the hands of the Board, and not the Members, of NextMedia Investors LLC.⁶

A chart depicting the composition of the Board and the relative power of Class A Members to appoint Board Members is appended to this application as Exhibit 11C. It is this power to appoint Board Members that is most meaningful voting power in NextMedia

Investors LLC.

The “TWP Members”⁷ of NextMedia Investors LLC have the right to elect two of the eight Board Members. Thomas Weisel Capital Partners, L.P. has a majority in interest among the TWP Members and controls their power to appoint Board Members. Ultimately Thomas Weisel Partners Group, LLC, through control of Thomas Weisel Capital Management, LLC and Tailwind Capital Partners, LLC, holds 100% voting control over Thomas Weisel Capital Partners, L.P. Accordingly, Thomas Weisel Capital Partners LLC can be said to control 25 percent of the votes in NextMedia Investors LLC. The two Board Members elected by the TWP Members are Thomas Weisel and Lawrence Sorrel.

A chart depicting voting control of the TWP Members votes in NextMedia Investors LLC is appended to this application as Exhibit 11D.

The “Management Members” of NextMedia Investors LLC have the right to appoint two of the eight Board Members of NextMedia Investors LLC and this can be thought of as a 25 percent voting interest in NextMedia Investors LLC. The LLC Agreement requires the Management Members to appoint Steven Dinetz and Carl Hirsch to the Management Member board seats, as long as Messrs. Dinetz and Hirsch are associated with NextMedia Investors LLC. If there ever is voting among the Management Members to appoint Board Members, it will be done on the basis of their relative interests in NextMedia Investors LLC. This would translate into the following percentage votes on the appointment of the two Management Members’ Board Members:

Two of NextMedia Investors LLC's eight Board Members are elected by GS Capital Partners 2000, L.P. and, therefore, GS Capital Partners 2000, L.P. can be said to hold 25 percent of the voting power in NextMedia Investors LLC. Presently, Kenneth Pontarelli the only Board Member elected by GS Capital Partners 2000, L.P. With a Goldman Sachs vacancy on the Board, Mr. Pontarelli casts two (2) votes on Board items. A chart depicting voting control of the interest of GS Capital Partners 2000, L.P. in NextMedia Investors LLC is appended to this application as Exhibit 11E.

In this connection, Assignee has requested that all officers and directors of The Goldman Sachs Group, Inc., other than members of the committee governing The Goldman Sachs Group, Inc. investment in NextMedia Investors LLC, be regarded as non-attributable in the ownership structure of NextMedia Investors LLC.

The "Alta Members"⁸ elect one of the eight NextMedia Investors LLC Board Members, representing 12.5 percent of the voting power in NextMedia Investors LLC. Alta Communications VIII, L.P. holds the majority in interest among the Alta Members and

controls their power to appoint a Board Member. Ultimately, Alta Communications VIII Managers, LLC holds 100% voting control over Alta Communications VIII, L.P. and controls the Alta Members' 12.5 percent voting interest in the Board of NextMedia Investors LLC. The Board Member elected by the Alta Members is Brian McNeill.

A chart depicting voting control of the Alta Members' votes in NextMedia Investors LLC is appended to this application as Exhibit 11F.

The "Weston Presidio Members"⁹ elect one of the eight NextMedia Investors LLC Board Members, representing 12.5 percent of the voting power in NextMedia Investors LLC. Weston Presidio Capital III, L.P. holds a majority in interest of the Weston Presidio Members and controls their 12.5 percent voting power on the Board. The voting interests in the Weston Presidio Members are ultimately controlled by Weston Presidio Capital Management III, LLC, which has 100% managing control of Weston Presidio Capital III, L.P. The Board Member elected by the Weston Presidio Members is James B. McElwee.

A chart depicting voting control of the Weston Presidio Members' 12.5 percent voting interest on the NextMedia Investors LLC Board is appended to this application as Exhibit 11G.
