Dear Ms. Dortch,

The outstanding Construction Permit for K259AU, issued August 3, 2004, contains as condition #3, impedance measurements of AM broadcast station KWG(AM) Stockton, CA. For reasons stated below, Calvary Chapel of Twin Falls, Inc. is requesting that this condition be removed from the underlying CP of K259AU and the 350 Application for K259AU, submitted to the Commission under BLFT-20050203AAR, be granted.

C.F.R. 47 Section 73.1692 states that if a broadcast licensee or permittee proposes to mount a broadcast antenna on an AM station tower or where construction is proposed within 0.8 km of an AM nondirectional tower or within 3.2 km of an AM directional station, the broadcast licensee or permittee is responsible for ensuring that the construction does not adversely affect the AM station..... The AM tower for KWG is located 2.15 km from the tower that K259AU is operating from, ASR # 1064433. Attached is the most recent modified license granted to KWG, dated 10/7/2004. The license states that KWG is operating nondirectional day and night. K259AU was placed on the air February 3, 2005, after KWG was granted a modified license to operate nondirectional day and night. According to 73.1692, because K259AU is located more than 0.8 km from the AM tower, condition #3 no longer applies to the underlying CP for K259AU.

Taking into consideration the above reason, Calvary Chapel of Twin Falls, Inc. respectfully requests that Special Condition #3 be removed from the underlying CP, BMPFT-2000504AAX, K259AU, Stockton and license application BLFT-20050203AAR be granted.
