

DESCRIPTION OF TRANSACTION

By this application, Resort Television USA, LLC (“RTUSA”), the licensee of K36DB, Sweetwater Creek, etc., Colorado, and K26GY, Breckenridge, Colorado, seeks Commission consent to the transfer of control of Resort Sports Network, Inc. (“RSN”), the direct parent and 100% owner of RTUSA, from the Current Shareholders of RSN to the New Shareholders of RSN. This transfer of control will be effectuated through a merger between RSN and a newly formed company, RSN MergerSub, Inc., which is wholly owned by the proposed transferees through a holding company, RSN Acquisition, Inc. RSN will be the surviving entity in the merger, meaning that after the merger the shareholders of RSN Acquisition, Inc. will be the New Shareholders of RSN.
