ENGINEERING STATEMENT ON MULTIPLE OWNERSHIP

PURPOSE AND SCOPE

This Engineering Statement has been prepared on behalf of Long Point Communications, LLC (“LPC”), the applicant for the assignment of licenses of the following seven broadcast facilities:

LPC is not currently the licensee of any other broadcast facilities in the area of the above listed stations.

This Statement addresses the overlap of the FM 70 dBu F(50,50) contours and AM 5.0 mV/m contours of the above listed stations.

DEFINED MARKETS

Figure 1 of this Statement is a map showing the 70 dBu F(50,50) contour of all of the above listed FM facilities (shown in orange) and the 5.0 mV/m daytime ground wave contour of all of the above listed AM facilities (shown in green). As shown on that Figure, each of the listed facilities overlaps in part one or more of the other listed facilities.

Three markets requiring analysis are defined. The first, labeled Market 1, is the area defined by the overlap of four affiliated stations, WLLW(FM), WFLK(FM), WGVA(AM) and WNYR-FM. The second, labeled Market 2, is the area defined by the overlap of three affiliated stations, WAUB(AM), WLLW(FM) and WNYR-FM. The third, labeled Market 3 is the area defined by the overlap of two affiliated stations, WGVA(AM) and WCGR(AM).

NON-AFFILIATED STATIONS IN MARKETS

Figure 2 is a plot of the defined Market 1 and the transmitter sites and 70 dBu contours of some of the non-affiliated stations in Market 1.

In addition to affiliated stations, the following three non-affiliated stations have antenna sites located within the contour of one or more of the affiliated stations defining Market 1.

In addition to affiliated stations, the following three non-affiliated stations have FM 70 dBu F(50,50) or AM 5.0 mV/m contours which overlap in part one of more of the FM 70 dBu F(50,50) or AM 5.0 mV/m contours of the affiliated stations defining Market 1.

Figure 3 is a plot of the defined Market 2 and the transmitter sites of some of the non-affiliated stations in the Market 2.

In addition to affiliated stations, the following four non-affiliated stations have antenna sites located within the contour of one or more of the affiliated stations defining Market 2.

Figure 4 is a plot of the defined Market 3 and the transmitter sites and 70 dBu and 5.0 mV/m contours of some of the non-affiliated stations in Market 3.

In addition to affiliated stations, the following non-affiliated station has its antenna site located within the contour of one of the affiliated stations defining Market 3.

In addition to affiliated stations, the following two non-affiliated stations have FM 70 dBu F(50,50) or AM 5.0 mV/m contours which overlap in part one of more of the AM 5.0 mV/m contours of the affiliated stations defining Market 3.

CONCLUSIONS

Market 1 has four affiliated stations and a minimum of six non-affiliated stations in the market.

Market 2 has three affiliated stations and a minimum of four non-affiliated stations in the market.


Market 3 has two affiliated stations and a minimum of three non-affiliated stations in the market.




