Dear Mr. Denning:

This is in reference to the request filed on August 23, 2017. RLH requests a further extension of the STA granted on January 24, 2012, and extended to continue operation with parameters at variance to allow time to file the required FCC Form 302 application.<sup>1</sup> In support of the request, RLH states that additional time is needed to complete a proof and file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and RLH may

continue to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits to allow time to file the new license application before the construction permit BMP-20170227ACD expires on the date shown below. It will be necessary to further reduce power or cease operation if complaints of interference are received. RLH must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 18, 2018**.
