New FM – Channel 259A – Mason, TX
Allocation Study

This application is being filed as part of a contingent application group. This group consists of the instant application for a new station on Channel 259A at Mason, as well an application for a new station on Channel 260C3 at Hunt, Texas. The Mason and Hunt allotments were included in FM Auction #62, and Munbilla Broadcasting Properties, Ltd., was the winning bidder for both allotments.

The attached spacing study shows that the proposed Channel 259A transmitter site meets the domestic co-channel and adjacent channel spacing requirements for Class A stations as prescribed in §73.207 of the Commission's Rules, with the following exceptions:

The proposed operation is short-spaced to the concurrently-filed application for a new station on Channel 260C3 at Hunt, also by Munbilla Broadcasting Properties, Ltd. Processing pursuant to §73.215 of the Commission's Rules is requested with respect to the Hunt 260C3 application, and the attached allocation study map is included to demonstrate the lack of prohibited contour overlap with that facility.

The proposed operation is short-spaced to the vacant allotment on Channel 258C1 at Eldorado. Processing pursuant to §73.215 of the Commission's Rules is requested with respect to the Eldorado allotment, and the attached allocation study map is included to demonstrate the lack of prohibited contour overlap with that facility assuming Eldorado operation with maximum Class C1 facilities.
