NATURE OF APPLICANT

Covenant Network is a Missouri non-profit corporation. It has been found qualified by the FCC pursuant to Section 73.503 of its Rules to operate radio stations in the non-commercial portion of the FM Band. Further, all of the AM Broadcast Stations of which it is the licensee are “non-commercial educational” in nature.

Covenant Network intends to use the proposed FM translator station non-commercially to rebroadcast one of its non-commercial educational primary stations. Therefore, this application is categorically exempt from the payment of application filing fees pursuant to Section 1.1116(c) and Section 1.1116(e) of the FCC’s Rules.
