

DEMONSTRATION OF COMPLIANCE WITH MULTIPLE OWNERSHIP RULES

Gold Coast Broadcasting LLC (“Gold Coast”), the licensee of KCAQ(FM), Oxnard, California, hereby demonstrates that the instant modification application fully complies with the Commission’s new multiple ownership regulations.¹

KCAQ(FM) is “home” to the Arbitron Oxnard-Ventura radio market. Gold Coast is the licensee of two additional FM radio stations and 3 AM radio stations in the Arbitron Oxnard-Ventura radio market: KOCF(FM), Camarillo, California, KFYV(FM), Ojai, California, KUNX(AM), Santa Paula, California, KVTA(AM), Port Hueneme, California, and KKZZ(AM), Ventura, California. Gold Coast has no attributable ownership interest, whether by ownership, LMA, or JSA, in any other station in the Oxnard-Ventura market.

The most recent available Arbitron data for the Oxnard-Ventura radio market reveals that there are 19 commercial and noncommercial radio stations in the market. *See* the BIA FCC Geographic Market Definition for Oxnard-Ventura, attached hereto.² Under the new broadcast multiple ownership rules, in a radio market with between 15 and 29 commercial and noncommercial radio stations, an entity may lawfully own, operate, and control up to 6 radio stations, only 4 of which may be in one class. Accordingly, Gold Coast’s continued ownership of three FM stations and three AM stations in the market is fully compliant with the new multiple ownership rules.³

² The attached list indicates that Gold Coast’s six stations in the market are “owned” by Point Broadcasting Company (“Point”). Point is the parent company of Gold Coast, which is actually the station licensee.

³ Under the Commission’s new multiple ownership rules, a modified contour overlap analysis is also required if any station subject to the application does not have its community of license located within the geographic boundaries of any Arbitron Metro. *See Report and Order* at ¶ 286. KCAQ is assigned to the Oxnard-Ventura Arbitron metro and Oxnard, KCAQ’s community of license, is physically located in the Oxnard-Ventura Arbitron metro market, which encompasses Ventura County. Accordingly, a modified contour overlap analysis is not required.
