CALVARY CHAPEL OF DADE COUNTY, INC.  
ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation under Florida law.

1. NAME. The name of this corporation is CALVARY CHAPEL OF DADE COUNTY, INC.

2. PRINCIPLE PLACE OF BUSINESS. The offices and principle place of business of the Corporation shall be located at:

2229 S.W. 57th Court  
Miami, Florida 33455

3. PURPOSE. The purpose for which this corporation is organized is for the advancement of religion, charity, education and any other related or corresponding charitable purposes by the distribution of its funds for such purposes.

FURTHER, the corporation is to operate exclusively in any other manner for such religious, charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including public foundations and private foundations.

4. MEMBERS. The qualification for members and the manner of their admission shall be regulated by the Bylaws for this corporation.

5. STOCK. This corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in these articles.

6. DISTRIBUTION OF ASSETS. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, education, or religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.

7. TERM. The corporation shall exist perpetually.

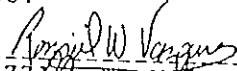

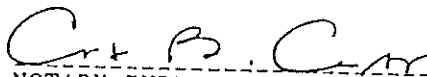
