**CONTEMPORARY COMMUNICATIONS, LLC**

Contemporary Communications LLC, owned by Larry G. Fuss, is the proposed assignee of KNWJ(FM) Leone, AS. Fuss is also the President and majority stockholder in South Seas Broadcasting, Inc., licensee of KKHJ-FM Pago Pago, AS, and WVUV-FM Fagaitua, AS. All stations have overlapping contours. Accordingly, the following information is submitted to document compliance with Section 73.3555(a) of the Commission's Rules & Regulations.

Common ownership of the three stations is permissible pursuant to Section 73.3555(a)(1)(iv) of the Commission's Rules, which specifies that:

*"In a radio market with 14 or fewer commercial radio stations, a party may own, operate, or control up to 5 commercial radio stations, not more than 3 of which are in the same service (AM or FM), except that a party may not own, operate, or control more than 50% of the stations in such market".*

The combination of KNWJ(FM), KKHJ-FM and WVUV-FM would result in common ownership of three of the nine stations in the market.

**DEFINITION OF MARKET**

As specified in Section 73.3555(a)(4):

*"The number of stations in a radio market is the number of commercial stations whose principal community contours overlap, in whole or in part, with the principal community contours of the stations in question (i.e., the station for which an authorization is sought and any station in the same service that would be commonly owned whose principal community contour overlaps the principal community contour of that station)."*

The stations which define the radio market are the stations referenced above (KNWJ(FM), KKHJ-FM and WVUV-FM). Because American Samoa is a relatively small land mass (the main island of Tutuila on which all nine stations are located, is only 55 square miles in size), all stations provide principal community coverage to the entire island, and thus, no map depicting the coverage of each station is submitted.
