

TECHNICAL STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS
CC LICENSES, LLC

This statement and the attached figures were prepared on behalf of CC Licenses, LLC ("CCLL"), a licensee subsidiary of Clear Channel Communications, Inc. ("CCC"). CCLL proposes to acquire WQRK-FM, Canton, OH. This analysis considers the following radio stations under present or proposed common ownership, because certain of these stations have overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations), or are located in, or home to, the same Arbitron Metro Market:¹

Arbitron Market Study

WRQK-FM is located in the Canton, OH Arbitron Metro. This proposal is in compliance with the local radio ownership rules for that Arbitron Metro, as evidenced by Table 2 below:³

¹ A station is considered to be "located in an Arbitron Metro" if the station's community of license is located within the boundaries of that Metro, or, the station is listed as "Home" to that Metro by BIA. None of the stations in Table 1 are attributable by virtue of a time brokerage agreement or joint sales agreement.

Contour overlap of WRQK-FM, as depicted in Figure 1, also occurs with commonly-owned stations whose communities of license are located in the Akron, OH, Cleveland, OH, and Youngstown-Warren, OH Arbitron Metro markets.

Interim Contour-Overlap Analysis

An interim contour-overlap analysis is not required because the principal community contour of WRQK-FM does not intersect the principal community contour of any commonly-owned or attributable station that is not licensed to a community in an Arbitron Metro.

⁵ Status: "a" -- the station is reported by BIA as "Home" to this Arbitron Metro; "g" -- the station's community of license is located within the geographic boundaries of this Arbitron Metro; "b" -- the station is both listed by BIA as "Home" to this Arbitron Metro, and its community of license is located in this Arbitron Metro.

⁶ The community of license of WJER-FM has been modified by "Report and Order," DA 06-845 in MB Docket No. 04-3776 (released April 14, 2006) from Dover, Ohio, to North Canton, Ohio. North Canton, Ohio is located in Stark County, Ohio, which is geographically within the Canton, OH Arbitron Metro. It is anticipated that WJER-FM also will be reported by BIA as being "Home" to the Canton, OH Arbitron Metro.

Conclusion

In the Canton, OH Arbitron Metro Market there are at least 14 radio stations, including the 3 CCC-owned FM stations, one of which is the WJER-FM (CP). Based on the above, it is concluded that the proposed ownership combination complies with Section 73.3555(a) of the FCC Rules.
