Proposed assignee Armada Media – McCook, Inc., is a wholly-owned subsidiary of Armada Media Corporation (“Armada”). In addition to being the parent of Armada Media – McCook, Inc., Armada Media Corporation is also the sole shareholder in two other entities, Armada Media – Aberdeen, Inc., and Armada Media – Menominee, Inc., which have the media interests set forth below:

None of the stations in which Mr. Bernier holds an attributable interest has a principal community contour that overlaps the stations of which Armada Media – McCook, Inc., is the proposed assignee in the instant application.

John Lynch, who holds an attributable interest in Armada Media Corporation, is a principal in Broadcast Company of the Americas, LLC, which holds authorizations under Section 325 of the Communications Act to provide programming over two Mexican stations (XEPRS(AM) and XHBCE-FM) and which has pending before the Commission an application for authority under Section 325 to provide programming over a third Mexican station (XEKTT). All three of these stations place a signal over the San Diego, California, market. The principal community contours of these three stations do not overlap the principal community contours of any of the stations that are the subject of the instant application.
