

Compliance with 47 C.F.R. Section 73.3555(a)
Local Radio Station Ownership

Upon grant of the subject transfer of control application and concurrently filed transfer of control applications (collectively, the "315 Applications"), the transferee, Broadcasting Media Partners Inc. ("BMPI" or the "Transferee"), and its shareholders will have attributable interests in broadcast stations licensed to subsidiaries of Univision Communications Inc. ("Univision"). The Transferee has certified "No" to Question 8(b) of Section IV on each of the 315 Applications because, in certain of the Univision markets, the transaction will implicate the Commission's multiple ownership and cross-ownership rules, 47 C.F.R. Section 73.3555. Those instances are detailed in Transferee's Exhibits 18-A, 18-B and 18-C, which, for convenience, are attached to each of the 315 Applications.

Specifically, grant of the 315 Applications will result in the Transferee and/or parties to the Transferee having attributable interests in multiple full-power radio stations in metropolitan areas as defined by Arbitron (a "Metro") as reported by BIA Financial Network, Inc. ("BIA"), and in full-power radio stations whose communities of license are located outside of the geographic boundaries of any Arbitron Metro. This exhibit demonstrates compliance (except where noted) with 47 C.F.R. Section 73.3555(a), the local radio station ownership rule, of the existing radio station interests of Univision, as well as new combinations of attributable interests in radio stations of parties to the transferee that would result from the proposed transaction.

Part I addresses the applicable Arbitron Metro markets. The BIA "FCC Geographic Market Definition" reports for the Arbitron Metros identified below are attached at Appendix A hereto. The total number of radio stations in each Arbitron Metro set forth in Part I exclude those stations listed by BIA with a market designation date less than two years prior to the date of the instant application.

Part II addresses compliance with 47 C.F.R. Section 73.3555(a) pursuant to the interim contour-overlap methodology for the four subject stations that have been identified as having communities of license located outside of any Arbitron Metro.

II. INTERIM CONTOUR-OVERLAP MARKETS

Five of the radio stations licensed to subsidiaries of Univision have been identified as licensed to communities located outside of the geographic boundaries of any Arbitron Metro. Consequently, as set forth in the *Report and Order, 2002 Biennial Regulatory Review - Review of the Commission's Broadcast Ownership Rules and Other Rules*, 6/ this exhibit also demonstrates compliance with 47 C.F.R. Section 73.3555(a), the local radio station ownership rule, pursuant to the interim contour-overlap methodology in regards to these five stations. As set forth in the Engineering Statement attached at Appendix B hereto, the common attributable interests in all such interim contour-overlap radio markets comply with 47 C.F.R. Section 73.3555(a).
