IN THE MATTER OF THE PETITION FOR THE INCORPORATION OF THE TOWN OF  
LOMPOC.

It Appearing to the Board that an election was duly held within the territory proposed to be incorporated in said Town of Lompoc; that such election was conducted in accordance with the general election laws of the State on the 31st day of July 1888 after due and legal notice given as required by law and the order of this Board.

And it further appearing that the returns of said election were delivered to the Clerk of this Board. The Board proceeded to canvass the returns of said election and hereby declare the result to be as follows: Whole number of votes cast One Hundred and seventy one (171). For incorporation, One Hundred (100), Against Incorporation, Seventy one (71). For Member of Board of Trustees, H. S. Rudolph received One Hundred and nine (109) votes. For Member of Board of Trustees, James Sloan received one hundred and thirty one (131) votes. For Member of Board of Trustees, Wm. H. Saunders received one hundred and thirty three (133) votes. For Member of Board of Trustees, W. J. McGee received one hundred and four (104) votes. For Member of Board of Trustees, J. D. Black received one hundred and five (105) votes. For Member of Board of Trustees, W. S. McKay received Sixty (60) votes. For Member of Board of Trustees, A. Lansdell (sp??) received fifty none (59) votes. For Member of Board of Trustees, H. W. Fabing received Sixty (60) votes. For Member of Board of Trustees, M. Pomeroy received thirty-five (35) votes. For Member of Board of Trustees, Chas. Fisk received one vote. For Member of Board of Trustees, J. W. Harris received one vote. For Member of Board of Trustees, W. B. Gray received one vote.

For Clerk Henson Poland received one hundred and seventeen (117) votes. For Clerk William Barker received thirty three (33) votes. G. For Treasurer, G. W. Saunders received one hundred and forty two (142) votes. For Marshall William Shean received one hundred and four (104) votes. For Marshall Walter Mansell received forty-two (42) votes. For Marshall B. F. Tucker received three (3) votes. For Marshall B. L. Tibbits received one (1) vote.

We the Board of Supervisors of the County of Santa Barbara, State of California do hereby certify and declare that at an election held within the boundaries of the territory of the proposed incorporation of the Town of Lompoc on the 31st day of July 1888 for the purpose of determining whether the same should be incorporated or not, and for the election of officers prescribed by law for Municipal Corporations of the Sixth Class, a majority of the votes were cast "For Incorporation" and the said Territory as hereinafter described and bounded is hereby declared to be duly incorporated as a Municipal Corporation of the Sixth Class under the name and style of "The Town of Lompoc".

And the following named persons having received respectively the highest number of votes for the several offices of such Municipal Corporation are hereby declared duly elected to the offices described as follows towit:

The boundaries of said Town of Lompoc are declared and determined to be as follows: Beginning at the S.E. corner of Farm Lot No. 11; thence West along the South boundary lines of Farm Lots Nos 11, 15, 20 and 24 to the S.E. corner of Farm Lot 29; thence South on the East boundary line of Farm lots 30, 31 and 92 to the N.E. corner of Farm lot 88, thence East on the North boundary lines of farm lots 89 and 90 to the N.E. corner of said Farm Lot 90; thence South on the East boundary line of said Farm lot 90 to the N.W. corner of Farm Lot 95; thence east on the North boundary lines of Farm Lots 95, 97, 163 and 98 to the N.E. corner of said Farm Lot 98; thence North on the West boundary lines of Farm Lots 99, 161, 100 and 4 to the place of beginning. The foregoing description of lands embracing the said Town and Suburban lots of the Town of Lompoc, is in accordance with that certain Map entitled Map of the Subdivision of the Rancho Lompoc and Mission Vieja in Santa Barbara County California, surveyed April 1875 by M.V. Bennett and where said Map, together with the field notes of the survey of said Ranchos from which said Map was compiled, were filed for record in the office of the County Recorder of said Santa Barbara County, October 10th 1877 and the said field notes recorded in Book "S" of Deeds on pages 138 to 216, both inclusive and which said map and field notes are made a part hereof for purposes of more perfectly describing and defining the boundary to the said Corporation.
