White Park Broadcasting proposes to change the City of License for KHNA from Hanna WY to Warren Air Force Base WY and in doing so, will also change reference coordinates to 41-16-38 N 104-45-06 W. As shown in *Figure 1*, This location meets spacing requirements specified in 47 C.F.R. 73.207 with 1 exception explained below. This location is also mutually exclusive with KHNA's current Construction Permit, BNPH-20060310AAL and allocation point. There are no major obstacles between the proposed allotment coordinates and any portion of Warren AFB WY, and the entire populated area of Warren AFB is within 32.6 km of the coordinates.

One record in the current CDBS shows the proposed operation to be prohibited short spaced to an allotment for 277C2 allocated to Cheyenne WY. The Commission's Report and Order RM-10960 released November 29, 2006, specifies "the Table of Allotments to reflect only vacant allotments that do not correspond to an authorized station or reserved assignment." The table of allotments (Appendix A, page 37 to this R&O) as published in this R & O does not contain any open allotment for Cheyenne. (*Figure 1*) This allotment was part of RM-bg-103 filed by Mountain States Radio in 2004 (pre-dating the R & O) and was denied by the Commission in September 2004. Thus this record is an error and can be disregarded and there is no prohibited short-spacing. As of the date of this amendment, this allotment is no longer listed in the database.
