As the attached stock transfer agreements reflect, on January 1, 2011, Josiah P. Rowe III transferred his personal interest in the licensee (36.4% of the voting shares and 3.6% of the total assets) in equal parts to his four children—Sallie A. Roberts, Jeanette R. Cadwallender, Florence C. Barnick, and Josiah P. Rowe IV. All four transferees were already holders of voting stock in the licensee at that time.

As of January 1, 2011, Josiah P. Rowe III was the sole trustee of his deceased wife's trust, the Anne W. Rowe Family Trust, which also holds 36.4% of the voting shares in the licensee and 3.6% of the total assets. However, because Josiah Rowe III was simply the trustee of the shares held by the Trust, and because all the shares he transferred went to current shareholders, the licensee was not aware at that time that the January 1, 2011 transfer might have effected a transfer of control.

As soon as reasonably possible after becoming aware that control may have been transferred on January 1, 2011, licensee submitted the instant application.




