**PETITION FOR TOLLING**

Potter Radio LLC ("Potter"), by his attorney, hereby respectfully requests the Audio Division to issue a decision, tolling the expiration of the above-referenced original construction permit ("Permit").

1. Potter is the proposed assignee<sup>1</sup> of FM Translator Station K281BQ currently located at McPherson, Kansas, with a contingent application<sup>2</sup> on file to relocate the Station to Bartlesville, Oklahoma to be used in conjunction with its AM facility KPGM, Pawhuska, Oklahoma. Potter's application was filed in accordance with the FCC'S *Public Notice, DA 15-1491, (released December 23, 2015)*, implementing provisions of the FCC's *Revitalization of the AM Radio Service, First Report and Order*
