
EXHIBIT 2-1 PURPOSE AND ENGINEERING STATEMENT

THE PURPOSE OF THIS LICENSE TO COVER IS TO CHANGE BACK TO DIRECT METHOD OF POWER MEASUREMENT.

TWO FM TRANSLATOR STATIONS WERE INSTALLED(W296CW AND W244BC) AT THIS FACILITY, AND DURING THE CONSTRUCTION, THE FCC REQUIRED THAT INDIRECT METHOD WAS REQUIRED TO BE USED FOR POWER MEASUREMENTS DURING CONSTRUCTION. NOW THAT CONSTRUCTION HAS BEEN COMPLETED ON BOTH TRANSLATORS, WE ARE FILING THIS APPLICATION TO RETURN TO THE DIRECT METHOD OF POWER MEASUREMENT.

DAYTIME AND NIGHTTIME ANTENNA CURRENT MEASUREMENTS WERE RECORDED BEFORE AND AFTER CONSTRUCTION, AND NO CHANGE IN ANTENNA CURRENT MEASUREMENTS HAVE BEEN DETECTED, ASSURING THAT NO CHANGES IN THE AM ANTENNA IMPEDANCE HAVE OCCURRED FROM THE INSTALLATION OF THE ANTENNA SYSTEMS OF THE TWO TRANSLATOR STATIONS .
