RE: Exercise of Option of Meridian Communications of Montana, Inc.,
pursuant to March 3, 1997 Stock Purchase Agreement

Dear Paul:

Notice is hereby given pursuant to Sections 6(a) and (b), and 14, of the Stock Purchase Agreement dated March 3, 1997, by and among Uhlmann/Latshaw Broadcasting, LLC (hereinafter "ULB"), Rocky Mountain Broadcasting Company, (hereinafter "RMBC"), and Meridian Communications of Montana, Inc. (hereinafter "Meridian") ("Agreement"), that Meridian is exercising its option right, subject to prior FCC approval, to acquire ULB's 51% interest in RMBC for ten thousand dollars (\$10,000) ("Purchase Price"), which is the lesser of (a) the fair market value of the assets of RMBC used in connection with the Station (as appraised by an independent appraiser mutually acceptable to ULB and Meridian) minus both the Investment Price and the Option Price, and (b) ten thousand dollars (\$10,000).

This exercise of option and notice thereof is timely given pursuant to Section 6(a) of the Agreement as it is within the 30 day period commencing on the date which is twelve months after the Station's August 15, 1998 sign-on.

Pursuant to Section 6(c) of the Agreement, Meridian shall pay the Purchase Price to ULB at Closing (defined below), in immediately available funds. Pursuant to Section 6(d) of the Agreement, Closing shall occur within five (5) business days after approval of the transfer of control application (FCC Form 315) ("Application") by the Federal Communications Commission ("FCC") becomes a Final Order (herein referred to as "Closing"). Meridian shall begin processing the Application right away and would like to have the Application on file with the FCC no later than August 31, 1999, with Meridian paying all filing fees and related expenses. Meridian requests ULB's cooperation in promptly seeking the necessary FCC approval.
