JOINT PETITION FOR TOLLING

Jared A. Nix (“Nix”) and WCBR, Inc. (“WCBR”) (jointly the “Petitioners”), by their attorney, hereby respectfully requests the Audio Division to issue a decision, tolling the expiration of the above-referenced original construction permit (“Permit”).

1. The Petitioners have filed to assign¹ the Permit held by Nix to FM Translator Station W282BV (the “Station”) currently located at Morrill, Kentucky. In addition, Nix has filed to relocate the Station from Morrill to Richmond, Kentucky so that it may be used in conjunction with WCBR’s AM facility in Richmond, Kentucky². The relocation application³ was filed in accordance with the FCC’S *Public Notice, DA 15-1491, (released December 23, 2015)*, implementing provisions of the FCC’s *Revitalization of the AM Radio Service, First Report and Order and Further Notice of*


Proposed Rule Making, FCC 15-142, (released October 23, 2015) (“Revitalization Order”)

2. The Permit BNPFT-20130829AER is scheduled to expire on November 8, 2016. Pursuant to *Footnote 36* of the *Revitalization Order*, Petitioners seek a waiver/tolling of the expiration deadline to the longest period permitted by the Commission.

3. Under the circumstances, good cause exists for the tolling of this Permit. Therefore, Petitioners respectfully requests that this Permit be tolled.


