With reference to your letter dated May 6, 2003, received in this Directorate General on May 27, 2003, with entry sheet number 4466, in which you propose modifying concession tables “A” and “B” in Appendix 2 of the Agreement between the Government of the United Mexican States and the Government of the United States of America regarding the FM Broadcasting Service on the 88 to 108 MHz band in order to eliminate the overlap areas caused by the proposal to add channel 274B\* in Esperanza, B.C. to the above-mentioned Table “A” in relation to its allocation in channel 275B in San Diego, CA. and the proposal to modify the above-mentioned Table “B” to change the location and type of channel 224AA in South Padre Island, TX. with respect to our allocation in channel 222B in Goliat, Tamps.

In the case in question, I would like to inform you that this department is of the opinion, after an initial study, that your proposals can be accepted and for this reason they will be incorporated into Table “A” and “B” respectively in Appendix 2 of the above-mentioned Bilateral Agreement and will be registered as follows:
