Dear Ms. Dortch:

Red River Broadcast Co., LLC ("Red River") is the licensee of analog television station KVRR(TV), Fargo, North Dakota and the permittee of digital television station KVRR-DT, Fargo, North Dakota. On December 28, 2006, KVRR filed the above-referenced application (the "Application") seeking to modify the KVRR-DT construction permit. The modifications were necessary because the KVRR-DT antenna may not be placed at its authorized maximum height due to the current placement of the KVRR(TV) analog antenna in that location.¹

By letter dated February 27, 2007 from Clay Pendarvis, Esq., Associate Chief, Video Division, Media Bureau (the "Letter"), the Application was granted. However, the Letter appears to allege that Red River made false certifications on the FCC Form 381 maximization/replication certification form for KVRR-DT ("KVRR Certification").²

The proposed modification would result in a reduction of the facilities that you certified that you would construct as your permanent digital television station. While we are granting your modification application, we call your attention to the Second DTV Periodic Review Report and Order, 19 FCC



Rcd 18279, 18296 n. 81 (2004), wherein the Commission reminded licensees that false certifications may result in fines and loss of license.³

As noted above, Red River is physically unable to maximize KVRR's DTV facilities as intended because the existing KVRR(TV) analog antenna is located at the height authorized for maximized DTV operations. The Commission specifically recognized this problem and permitted stations to file requests for waiver on that basis.⁴ Red River has done so for KVRR and, in conjunction with the end of the digital transition and upon Commission authorization, Red River intends to move the KVRR-DT antenna to the maximized height and remove the analog antenna from service. Accordingly, KVRR requests that the Media Bureau clarify that the Application is fully consistent with the KVRR Certification and that the truthfulness of Red River's certification is not in question because Red River has been fully candid with the Commission.
