This Technical Statement was prepared on behalf of Cumulus Licensing, LLC (“Cumulus”), licensee of AM station WYMB, 920 kHz, Manning, South Carolina. Cumulus herein requests Special Temporary Authority (“STA”) to operate WYMB during daytime and nighttime hours using only the nighttime directional array, at reduced power during daytime hours. This operation is necessary to allow the station to maintain service to the community of Manning due to failure of the antenna switching network at the WYMB towers. Expedited processing of this application is requested to prevent loss of service to the community.

The station’s power will be monitored by the direct method using the nighttime common point current ammeter. Exhibit A demonstrates the proposed STA operation will not extend beyond the licensed 0.5 mV/m contour of WYMB. Protection of persons to high levels of radiofrequency radiation is maintained within the nighttime licensed limits.





