CBS Radio East Inc. (“*CBS Radio*”), licensee of FM radio station WLZL(FM), Annapolis, Maryland, herein seeks to change the principal community of this radio station to Bowie, Maryland. No changes to the WLZL technical facility are proposed.

Radio Multiple Ownership Study

This statement has been prepared using information provided by *CBS Radio* and their representatives to demonstrate compliance of the common ownership of the stations listed below with the Rules of the Federal Communications Commission as it governs common ownership of multiple radio stations serving the same market.

- WHFS(AM) Morningside, MD (Facility ID 28638)
- WIAD(FM) Bethesda, MD (Facility ID 9619)
- WLZL(FM) Bowie, MD (Facility ID 72177)(The subject of this application)
- WPGC-FM Morningside, MD (Facility ID 28632)
- WJFK-FM Manassas, VA (Facility ID 28625)

The BIA FCC Geographic Market Definition Report for the Washington, DC radio market, attached hereto, demonstrates that there are 64 full-power commercial and noncommercial stations in the Washington, DC radio market. Section 73.3555(a) of the FCC’s Rules provides that in a radio market with 45 or more full-power, commercial and noncommercial radio stations, a single entity may not have a cognizable interest in more than 8 commercial radio stations in total and not more than 5 commercial stations in the same service (AM or FM).

In the Washington, DC radio market, CBS Radio Inc., the indirect parent corporation of *CBS Radio East Inc.*, is the direct and indirect owner and operator of WHFS(AM) and WPGC-FM, Morningside, Maryland, WIAD(FM), Bethesda, Maryland, WJFK-FM, Manassas, Virginia, and WLZL(FM), Annapolis, Maryland. WLZL(FM), although currently licensed to Annapolis, is designated by BIA as “home” to the Washington, DC radio market. Thus, CBS Radio Inc. has

a cognizable interest in a total of 1 AM and 4 FM commercial radio stations in the Washington, DC radio market. Grant of this application will result in no change to CBS Radio Inc.'s cognizable interests in the Washington, DC radio market because WLZL is already treated as home to this market. Accordingly, the construction permit application fully complies with the FCC's local radio ownership rule (47 C.F.R. Section 73.3555(a))

Radio-Television Cross Ownership Study

CBS Radio is an indirect subsidiary of CBS Corporation, licensee of WJZ-TV, Baltimore, Maryland. At the request of CBS Radio, contour locations were determined to support the study of the proposed change in principal community with respect to the Commission's radio-television cross ownership Rule set forth in Section 73.3555(c) of the FCC's Rules.

The radio-television cross ownership Rule is triggered in cases where a 60 dB μ (1 mV/m) FM contour or a 2 mV/m AM contour encompasses the entire community of license of a commonly owned TV broadcast station. It is also triggered whenever a TV broadcast station Grade A contour encompasses the entire community of a commonly owned radio station.

Although the FCC Rules are silent regarding digital television service contours with respect to cross ownership, it is understood that the noise-limited DTV service contour (36 dB μ F(50,90)) is temporarily being utilized for this purpose. As shown in **Exhibit 5 - Figure 1**, the WJZ-TV noise-limited service contour encompasses both Annapolis and Bowie. Further, the WLZL 60 dB μ contour also encompasses Baltimore. Therefore, the cross ownership Rule is triggered by both the WLZL and WJZ-TV contour locations.

CBS Corporation holds an attributable ownership interest in eight other radio stations relevant to this analysis, in addition to WLZL.¹ The principal communities of seven of these radio stations are encompassed by the WJZ-TV noise limited service contour.² Therefore, the radio-television cross ownership rule is triggered for WJZ-TV and the following radio stations.

¹ CBS Corporation does not have an attributable interest in any television station in the Washington, D.C. market.

² The exception is Manassas, principal community of WJFK-FM, which is not encompassed by the WJZ-TV contour.

Under the radio-television cross ownership Rules, the FCC does not count radio stations located in one Arbitron market toward the limits on the number of radio stations a party may own in another Arbitron market, even when the radio stations are within the contour of a commonly owned TV station unless the relevant contour of an out-of-market radio station triggers the rule. In this instance, the 1 mV/m (60 dB μ) contours of WJFK-FM, WPGC-FM, and WIAD(FM), and the 2 mV/m contour of WHFS(AM) do not encompass all of Baltimore. See **Exhibit 5 - Figure 2.**

Because the Baltimore and Washington, D.C. radio stations are in two distinct radio markets, there are two separate radio-television markets. In Baltimore, CBS Corporation would have an interest in one television station (WJZ-TV) and five radio stations, including WLZL(FM). In Washington, D.C., CBS Corporation would have an interest in one television station (WJZ-TV) and four radio stations, including WLZL(FM). As shown in **Table A**, there are at least 20 independently owned media voices in each of the Baltimore and Washington markets. Accordingly, the construction permit application complies with the FCC's radio-television cross ownership rule.

In preparing the attached map, pertinent station data were extracted from the Commission's CDBS database. For AM stations, the distances to the 2 mV/m contours were computed using a digitized version of the Commission's estimated soil conductivity map, Figure M-3 and a

computer program that simulates the Commission's AM groundwave propagation curves. For the FM stations, distances to the 1 mV/m (60 dBμ) contours were determined using digitized 3 arc-second terrain data along radials spaced every degree from the transmitter site and an implementation of the Commission's TVFMFS computer program which simulates the FM propagation curves. A GIS mapping program was utilized to plot the principal community contour locations and generate the attached maps.

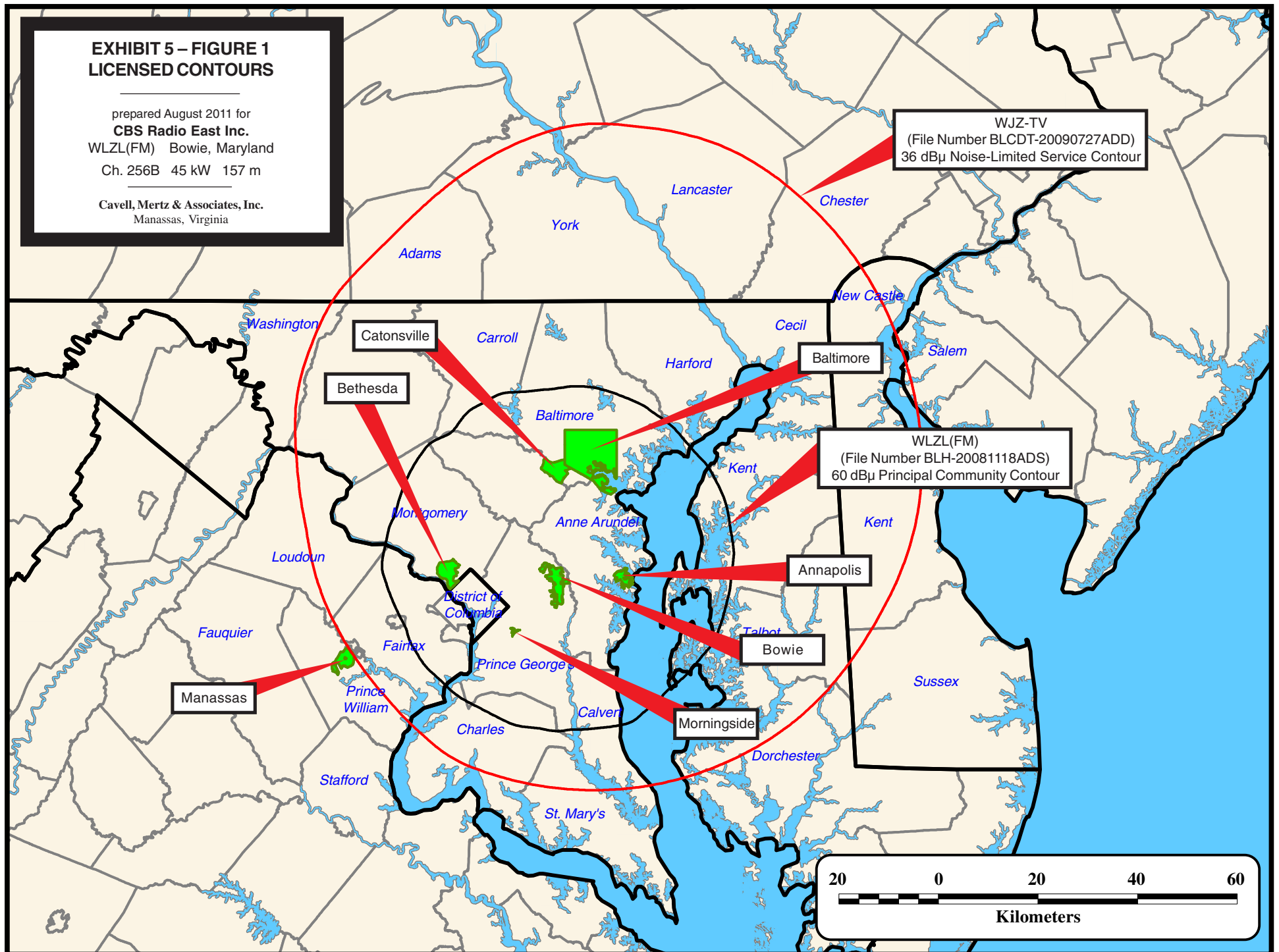

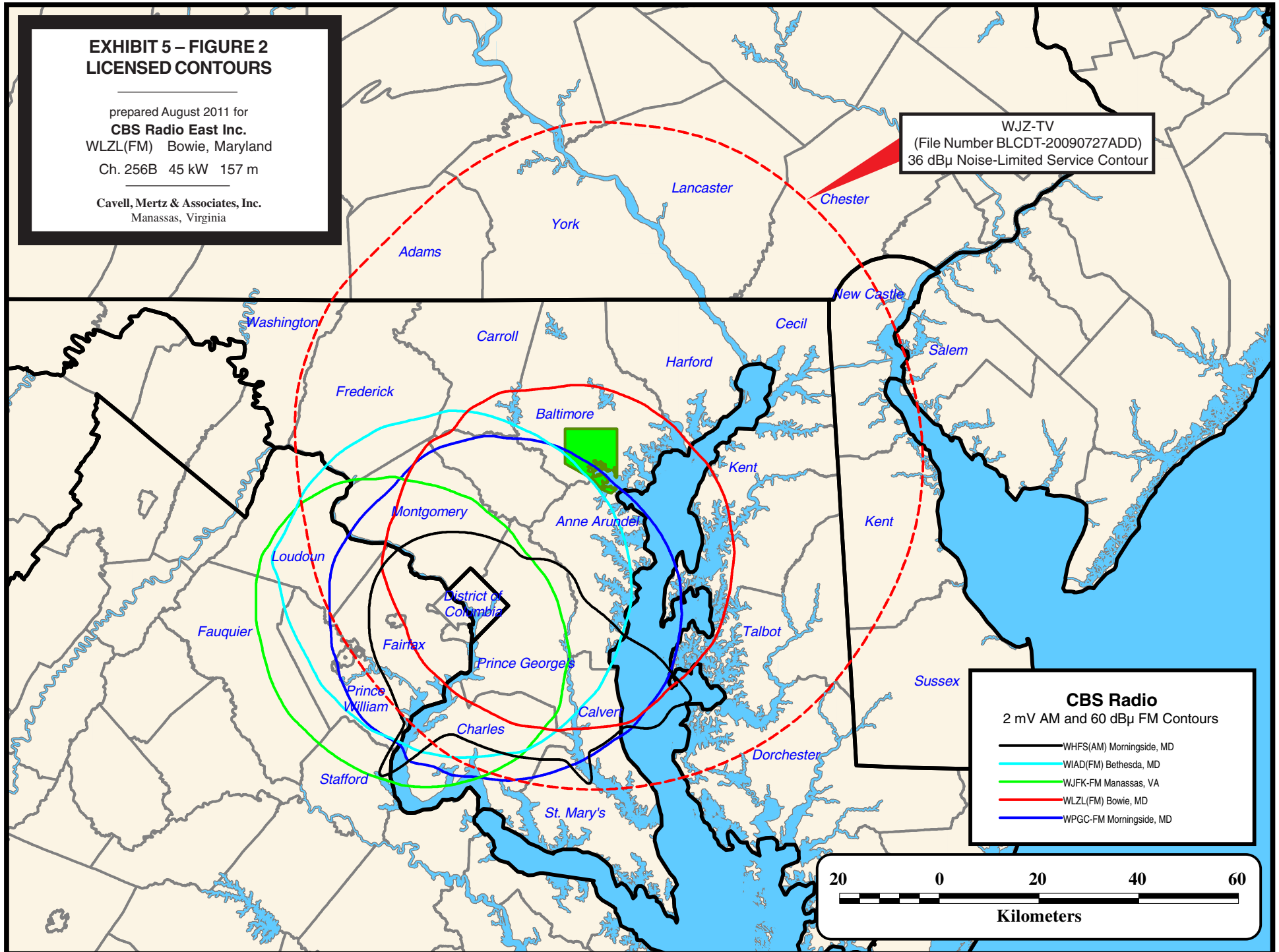
