

CERTIFICATE OF AMENDMENT  
OF  
ARTICLES OF INCORPORATION

Know all men by these presents, that the undersigned corporation, International Institute of Metropolitan St. Louis, for the purpose of amending its Articles of Incorporation, pursuant to Sections 34 and 35 of the Not-For-Profit Corporation Law of Missouri (R.S. Mo. §§ 335.070 and 355.075) hereby certifies:

1. The name of the corporation is International Institute of Metropolitan St. Louis.

2. The following amendment to the Articles of Incorporation was adopted:

Resolved, that Article Two of the Articles of Incorporation which reads:

ARTICLE TWO

The purposes for which the Corporation is organized are:

1. To assist the foreign-born and newly arrived immigrants of all nationalities in making adjustments to American life.

2. To promote a better understanding of the foreigner among Americans.

3. Pursuant to the foregoing purposes, to organize and conduct educational and social centers in the City of St. Louis, Missouri.

shall be amended to read as follows:

ARTICLE TWO

The purposes for which the Corporation is organized are:

1. To assist newly arrived immigrants and refugees of all nationalities in making adjustments to American life.

2. To promote a better understanding of these people in the metropolitan St. Louis community and to foster cross-cultural understanding.

3. To assist people in transition to become self-sufficient, self-fulfilled and productive members of the community.

4. For these objectives, to organize and conduct educational and social centers in the metropolitan St. Louis, Missouri community or other locations as approved by the Board of Directors to provide educational and personal services and social activities and programs.

3. The amendment above stated was adopted by a meeting of the members on February 9, 1989 at which a quorum was present, and such amendment received more than two-thirds of the votes entitled to be cast by members present at such meeting.


## Certificate of Amendment of a General Not For Profit Corporation
