**Parties to the Application**

This application and six concurrently-filed companion Form 314 applications (the “Applications”) seek FCC consent to assign the licenses of the 35 full-power television stations (and associated low power or TV translator stations) from seven licensee subsidiaries of Clear Channel Communications, Inc. to TV Acquisition LLC. 1/

TV Acquisition LLC is wholly owned by investment funds that are commonly controlled affiliates of Providence Equity Partners Inc. (“PEP”), and ultimately is controlled by certain principals of those funds. 2/ All information provided below describes attributable interests on consummation of the proposed transaction and is identical with respect to each of the Applications.
