Radio Market Analysis Sea-Comm, Inc. WMYT - FM Radio Station Carolina Beach, NC

Technical Statement

1. This technical statement and attached exhibits were prepared on behalf of CAROLINA CHRISTIAN RADIO, INC. ("CCR"), licensee of station WMYT, Channel 294A, Carolina Beach, North Carolina. CCR is submitting an application for a "Minor Change" in transmitter location, power and antenna height.
2. WMYT is not currently located within an Arbitron Metro defined market. Because of this the "Interim Contour-overlap Methodology" was used to establish the radio market for WMYT so that compliance with the FCC ownership rules could be proven. A map, Exhibit 5b, was prepared, and is attached, that indicates the current location for WMYT. The map also indicates the predicted 3.16 mV/m "City Grade" contour for the power and height of WLTT and radio broadcast stations WDVV – FM, WWIL – FM and WZDG - FM which are all 100 percent owned by CCR. Finally, all of the commercial, non-commercial, full-service AM and FM radio stations were indicated on the map that had their transmitters located within the City Grade contours. WMYT - FM has a City Grade Contour that commonly overlaps the WDVV - FM and WWIL – FM City Grade Contours which establishes Market 1. Market 2 is formed by the common overlap of WZDG – FM, WWIL – FM and WDVV - FM.

3. A list showing the number of AM and FM, full service, commercial and non-commercial radio stations within Radio Market 1 was prepared as Exhibit 5a and attached as part of this study. The list indicates that the WMYT - FM is located in Radio Market 1 which contains 5 AM and 12 FM radio stations, on the air, serving the defined Radio Market 1. By removing WMYT – FM from the total count puts the total number of radio station at 16.

The current FCC radio ownership rules indicate that in a radio market with between 15 and 29 (inclusive) commercial and noncommercial educational full-power radio stations, a party may have a cognizable interest in up to 6 commercial radio stations, not more than 4 of which are in the same service (AM or FM).

CCR owns and is licensee to WMYT – FM, WWIL – FM, WDVV – FM, WZDG – FM and WWIL – AM. As this study indicates, CCR, licensee of WMYT – FM, is currently, and if the proposed application is granted by the FCC, will remain in full compliance of the ownership rules in effect today.

5. The foregoing technical statement was prepared on behalf of CCR by M. E. Knight, a technical consultant. All data relating to AM and FM facilities used in this study was extracted from the CDBS database maintained by the FCC.
