

4. *Transmitter Output Power.*



5. *Certification of ERP.* Liberty hereby certifies its analog effective radiated power will remain as authorized after commencement of digital operations.
6. *Radiation Exposure Certification.* Liberty hereby certifies that its interim digital operations will not cause human exposure to levels of radio frequency radiation in excess of Section 1.1310 of the Commission's rules and is therefore categorically excluded from environmental processing pursuant to Section 1.1306 (b).
