TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Regent Broadcasting of Peoria, Inc. ("Regent"), proposed assignee of WIXO¹, Channel 289B, Peoria, Illinois; WVEL, 1140 kHz and WGLO, Channel 238B1, Pekin, Illinois and WFYR, Channel 247B1, Elmwood, Illinois. Principals of Regent have attributable interest in the licensee of WZPW, Channel 222B1, Peoria, Illinois.² Each of these stations is licensed to a community in a metro county in the Peoria, Illinois Arbitron Market. Therefore, this review will verify compliance with the Commission's multiple ownership rules in a rated market.

PEORIA, ILLINOIS ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are twenty-two AM and FM (commercial and non-commercial) stations listed in the Peoria, Illinois Arbitron Market (Market #150). Regent would be in control of four FM stations and one AM station in the same rated market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no

more than four in the same service, is permissible. Therefore, Regent's control of WIXO, WZPW, WVLE, WGLO and WFYR (four FM stations and one AM) in the Peoria, Illinois Arbitron Market is in compliance with the Commission's multiple rules.

3. Based on the foregoing, the proposed assignment of WIXO, WZPW, WVLE, WGLO and WFYR to Regent is in compliance with §73.3555 of the rules.

4. The foregoing technical statement was prepared on behalf of Regent Broadcasting of Peoria, Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.5 BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in that database which may be adverse to the information contained herein.


