

**OTHER AUTHORIZATIONS**

Mission Broadcasting of Joplin, Inc. ("Mission Joplin") has no authorizations other than Commission approval (not yet consummated) to be the licensee of KODE-TV, Joplin, Missouri. By means of the present application, the applicant proposes instead that the license of KODE-TV be assigned to Mission Broadcasting of Wichita Falls, Inc. ("Mission Wichita Falls"). Mission Wichita Falls, the proposed assignee, is the licensee of television broadcast station KJTL, Wichita Falls, Texas, Facility No. 7675; low power television station KJBO-LP, Wichita Falls, Texas, Facility No. 7670; and television translator stations K47DK, Grandfield, Oklahoma, Facility No. 7673, and K53DS, Lawton, Oklahoma, Facility No. 7672.

David S. Smith, the Director, President, Treasurer and sole shareholder of Mission Joplin and Director, President, Treasurer and sole shareholder of Mission Wichita Falls is also the Director, President, Treasurer and sole shareholder of the following corporations:

1. Mission Broadcasting III, Inc. ("Mission III"). Mission III submitted an application to the Commission for a construction permit for construction of a new station on channel 4 in Utica, New York, on July 24, 1996. The application was not accepted for filing by the Commission and was returned pursuant to a Commission letter of September 12, 1996 stating that Utica, New York is within a "freeze" area imposed by the Commission. Mission III submitted a petition for reconsideration on October 15, 1996, which remains pending, and an amendment to the application on July 17, 2000. (No facility number has been assigned.)
2. Bastet Broadcasting, Inc. ("Bastet"), the licensee of television stations WYOU(TV), Scranton, Pennsylvania, Facility No. 17919, and WFXP(TV), Erie, Pennsylvania, Facility No. 19707; and television translator stations W19AR, Clarks Summit, Pennsylvania, Facility No. 17007, W26AT, Williamsport, Pennsylvania, Facility No. 16994, W54AV, Mansfield, Pennsylvania, Facility No. 17002, W55AG, Williamsport, Pennsylvania, Facility No. 17004, W60AH, Stroudsburg, Pennsylvania, Facility No. 16989, and W66AI, Pottsville, Pennsylvania, Facility No. 17009.
3. Mission Broadcasting of Amarillo, Inc. ("Mission Amarillo"), the parent company of Mission Broadcasting of Amarillo License, Inc. ("Mission Amarillo License"), the licensee of television broadcast station KCIT, Amarillo, Texas, Facility No. 3372; low power television station KCPN-LP, Amarillo, Texas, Facility No. 7739; and television translator stations K30DZ, San Jon, New Mexico, Facility No. 51468; K35CG, Bovina, Texas, Facility No. 33717; K47DH, Clovis, New Mexico, Facility No. 33718; and K50FK, Amarillo, Texas, Facility No. 7736.

Nancie J. Smith, the wife of David S. Smith, is the Vice President and Secretary of Mission Joplin, Mission III, Bastet, Mission Amarillo, Mission Amarillo License and Mission Wichita Falls.
