TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared in conjunction with a proposed transfer of control of stations WGLD, 1440 kHz, and WSOX, Channel 241B, Red Lion, Pennsylvania and WSBA, 910 kHz, and WARM-FM, Channel 277B, York, Pennsylvania. WGLD, WSOX, WSBA and WARM-FM are each authorized in communities within metro counties in the York, Pennsylvania Arbitron Market (Market #103). As such, a review of the number of stations in the York, Pennsylvania market will be conducted to show the proposed combination is in compliance with the rules.

2. As shown on Exhibit #1, there are fifteen AM and FM (commercial and non-commercial) stations listed in the York, Pennsylvania Arbitron Market. The transferee would be in control of two FM and two AM stations in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, the transfer of control of station of WGLD, WSOX, WSBA and WARM-FM is believed to be in compliance with the Commission's radio ownership rules.

3. The foregoing technical statement was prepared by Graham Brock, Inc. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.0. BIA database.
