

EXHIBIT NO. 14 - ATTACHMENT A1

In July 1997, Bascomb Memorial Broadcasting Foundation ("Bascomb") was issued a construction permit (BPED-960614MA) to modify the transmission facilities of noncommercial educational station WDNA (FM), Miami, Florida. The construction permit specified use of a directional antenna.

Bascomb timely constructed the authorized facilities and on March 8, 1999 filed an application for license (BLED-990308KG) and a request for program test authority ("PTA").

By letter dated May 5, 1999, Commission staff issued limited PTA and held further processing of the license application in abeyance until a discrepancy in transmitter power output (based on the antenna gain, effective radiated power and transmission line efficiency) could be resolved.

Upon further investigation, Bascomb concluded that the underlying problem was with the design of the Jampro antenna. As installed on a tower with wide facings, the antenna did not deliver the pattern specified in the construction permit or in the proof of performance conducted by the manufacturer.

The purpose of this application is to obtain a construction permit that accurately reflects the performance of the directional antenna as installed. The pattern specified in this application is based on field strength measurements, rather than a theoretical model. The measurement data will be supplied to Commission staff on request.

As indicated in the following chart, the proposed facilities will protect all existing stations, authorizations and applications for facilities co-channel with WDNA, or on first, second or third adjacent channels.
