Interference Compliance

This is to show compliance with OET Bulletin 69 concerning interference to existing stations. Included is a table of stations which were considered in the instant application. As can be seen in the last column of the table, no interference is caused to any other station with the exception of K25AL. K25AL is predicted to receive interference in excess of 0.5% as allowed by the rules. However, Richard D. Tatham is also the president of Lake Havasu Christian Television and a simultaneous filing to flash-cut K25AL to digital is also being tendered. When K25AL is evaluated as a digital station, no interference in excess of FCC rules will be received from K25HD. Therefore, the application is in compliance with FCC rules.
