



2004/04-1. Fire Extinguisher: The fire extinguisher in need of service that was discovered during your visit *has been replaced with a serviceable unit*. We will strive to ensure that no extinguishers are over-looked during our next annual fire extinguisher inspection visit.

2002/04-2. Combustibles: The combustible boxes discovered immediately in front of the electrical panels *have been moved to a more suitable, safe location*. A 36-inch "safe zone" will be maintained adjacent to these panels now, and in the future.

2004/04-3. Vegetation: An annual clean-up program is conducted by KLST personnel via the use of contractors during the month of May each year. Periodic follow-up weed, grass and brush control procedures are conducted through-out the remainder of each year as required. This will continue to be an on-going program. The vegetation growth in and around the fenced-in area *has now been cut, removed and sprayed*.

A copy of the completed work by Coast-to-Coast Tower Company will be forwarded to you upon completion and certification of the work that they are performing. We currently expect for that work to be completed during the latter part of June, 2004.



The re-roofing of the KLST TV building located at 2800 Armstrong St. in San Angelo, TX to include:

1. Preparation of existing roof to receive Duro-Last roofing system as needed.
2. Mechanically fasten one layer of 3/8" Duro-Fold Board with approved fasteners in strict accordance with Duro-Last specifications.
3. Installation of Duro-Last single ply roofing membrane in strict accordance with Duro-Last specifications to the field and parapet walls of the building.
4. Installation of custom metal edge flashing to fascia.
5. Installation of Duro-Last custom fabricated flashing material to all roof penetrations, including any or all of the following: roof jacks, vent pipes, curbs and walls.
6. Installation of Duro-Last two-way vents at the rate of one (1) every 1000 square feet.
7. Protection of premises from roof debris; clean up and disposal of all debris.

Dear Lanny,

Enclosed please find the proposal for an 8 day/7 night Alaska cruise. There are a number of points about this program that I would like to clarify.

The Radiance of the Seas is a brand new ship having just made its inaugural voyage in March of last year, so I am confident about the amenities onboard this ship. Another big plus of this program (regarding price) is that it is round-trip from Vancouver. Most Alaska cruises are one-way either northbound to Seward or southbound from Seward to Vancouver. This helps to keep the price of the airfare down by being round-trip from Vancouver. Also, passengers arriving and departing from Seward have a 3-3.5 hour transfer to Anchorage for air service. Many times this results in having to take the group in a day early in order to be able to arrive at the airport or the port on time. The downside to this itinerary is that you have one less port on which to call (Seward).

Please note that I have included prices for two different categories of cabins. Category H cabins are all guaranteed outside staterooms, as can be found on deck three of the ship. http://www.royalcaribbean.com/asp/br_deck_layout.asp?sh=RD&d=03&s=EB5DE65EE5. Also included are prices for Category E3 cabins, which can be found on such levels as deck 7 of the ship. The main difference between these two categories is that the Category E3 cabins are located higher in the ship and have their own private balconies. See http://www.royalcaribbean.com/asp/br_deck_layout.asp?sh=RD&d=07&s=EB5DE65EE5 for more details. The private balconies are a big deal to cruisers, I've learned over the years, so you might want to consider this category.

The big variable in all this is the price of the airfare for 2004. It could be more or less than the estimate included in this proposal, which is based on prices in effect as of today. We won't be able to confirm the exact airfare until about a year out (if we buy into RCCL's air space) or eleven months out if we contract directly with the airlines for our own air space. That brings us to the topic of the advantages and disadvantages of these two methods of buying the airline seats we need for the group.

We can have Royal Caribbean handle the airline reservations for us using their existing fare agreements with the major airlines. Many times it is cheaper to let the cruise line book the air because of their existing agreements with the various airlines. However, this year I was able to purchase the seats directly from American Airlines for less than what



RCCL was offering (for another broadcast incentive customer doing the same itinerary). There are, however, some significant disadvantages to having the cruise line book the air for us.

Number one is that we don't get to choose the flights for the group and the group will not necessarily all travel together on the same flight. They may be split up on several flights.

The second concern is in the pre-reserved seating on the flights. The cruise lines' air departments are notorious for not pre-reserving seats or managing any pre-reserved seat blocks. This will most certainly result in a number of your clients not being able to sit with their traveling companions. From a personal standpoint when this happens, it always appears that I dropped the ball on the seating even though it is completely out of my control.

If we block the airline seats ourselves directly with a carrier, we will have much more control over these factors, but again, it may ultimately cost more to do this. The flights I have listed in this proposal assume that we are handling the airline reservations ourselves rather than through Royal Caribbean.

The last point on pricing is that in the above scenario is that your group of 60 people would qualify for a total of three complimentary berths (cruise only, based on 1/15 paying passengers, double occupancy), if you calculate this savings back over the entire group, the price per person effectively would be reduced to the levels listed in the pricing grid on page 5. Does that make sense? I would still bill you for each person at the "W/O Comps" figure but I would then issue you a credit for the three complimentary berths at the time of the final payment, which effectively reduces the price per person to the "Includes Comps" figure listed in the pricing grid.

I hope this isn't too confusing, but I'm sure we should talk about it so that you can feel comfortable about everything if you are interested in this as a possibility for 2004.

Thanks for giving me the opportunity to work with you again. As always, it will be fun and I am looking forward to it.

Friday, 8/20/04 San Angelo – Austin






Sunday, 8/22/04 – Inside Passage


Monday, 8/23/04 – Juneau Alaska


Mendenhall Glacier, a favorite of visitors is nearby.

Optional tours allow those who choose to participate an opportunity to get back to nature in Juneau. They can view the Mendenhall Glacier by air or by water, go whale watching, take a nature walk, or pan for gold. They can even wrap up their day at an Alaskan clambake!





Tuesday, 8/24/04 – Skagway, Alaska



This morning at 6:30AM, we arrive in Skagway. When gold was discovered in the Klondike region of the Yukon Territory (just across the border from Alaska), it resulted in the historic gold rush of 1898. As thousands of gold-crazed adventurers sought the best jumping-off spot for their arduous trek, they found the deepest penetration by boat was at the northern tip of the Lynn Canal, which gave rise to the town of Skagway.

The frontier spirit comes alive today on a choice of optional shore excursions from gold panning to kayaking. We can choose from such activities as boarding the historic White Pass & Yukon Railway, hiking along the Chilkoot “Trail of Gold” or soaring over glaciers on flightseeing tours.

Optional Dyea Adventure Bicycle Tour – A century ago, Dyea was a thriving community



of 10,000 gold stampeeders heading up the Chilkoot Trail to the Klondike. Now, nature has reclaimed the land. Enjoy a guided tour that takes you on a 1 ½ hour ride over flat dirt roads around the historic town site of Dyea. You’ll ride through the rain forest, visit historic ruins and the Chilkoot trail head. Out on the coastal tidal flats, you’ll view eagles, spectacular wildflowers and gorgeous

mountain scenery as you enjoy the exercise and fresh Alaskan air.

At 8:30PM this evening we lift anchor and sail from Skagway enroute to Hubbard Glacier.



Wednesday, 8/25/04 – Hubbard Glacier (cruising)



At 8:00AM this morning we arrive at Hubbard Glacier. The longest river of ice in North America, the Hubbard Glacier is also one of the most active glaciers of its kind in Alaska. Because the Radiance of the Seas is designed to provide its guests with outstanding views, we will be able to see this massive natural wonder with its 1,350 square miles of blue ice from just about anywhere on the ship.

At around noon, we turn to the south and make our way toward Ketchikan.

Thursday, 8/26/04 – Ketchikan



Just after lunch today, we arrive in Ketchikan. Ketchikan originated as an Indian fish saltery, but the town's growth began when it became a supply base and entry port for miners during the 1898 gold rush to the Klondike. Much of the town's colorful past is still evident, especially in the nearby Indian villages where colorfully carved Indian totem poles can be seen and the fascinating legends that surround them can be heard.




will be provided to reel them in!

Friday, 8/27/04 – Inside Passage (cruising)




Today is spent heading south toward Vancouver through the Inside Passage while enjoying the activities and amenities offered onboard the Radiance of the Seas.
