

Exhibit 12: Changes in Interests

Evangel Ministries, Inc. (“Licensee”) is a non-stock, non-profit organization and the licensee of noncommercial stations WEMI(FM), WEMY(FM), and WGNV(FM) and FM translators W269AZ, W231AS, W238BC, W269BG, and W297AK. Licensee is seeking the Commission’s consent to a transfer of control resulting from gradual changes in the membership of the Licensee’s Board of Directors.

Members of Licensee’s Board of Directors are selected pursuant to the Licensee’s Articles of Incorporation and Bylaws. The transfer of control for which consent is being requested has occurred gradually, though routine changes in board membership over time. Members of Licensee’s Board of Directors have staggered terms of three (3) years, meaning that changes typically occur as individuals serve out established terms of office, without reelection.

Old Board

The members of the EMI Board of Directors at the time of EMI’s last station acquisition (WEMY(FM)) (the “Old Board”) were Dennis Steffens, John Ciriacks, Dick Kendall, Robert Knox, J.R. Siewert, Donnie Slye, Bill Wanasek, Lee Webster, and Roy Jacobsen.

Following the annual meeting in April 2012, the members of the new EMI Board of Directors (the “New Board”) are Dennis Steffens, Peggy Ament, Dennis Hansen, Tori Lynne Kluess, Amy Martin, Trish Propson, Mike Randerson, Nora Schulz, Bill Shimon, Brian Schalk, Tony Wickham, and Robert Knox (Emeritus). Dennis Steffens and Robert Knox were members of the Old Board and will remain members of the New Board.
