


Technical Statement

Channel 268A – 101.5 mHz

This Technical Statement confirms the fact that WNVE, Ceiba, PR can operate on Channel 268A and be in compliance with Section 73.207 spacing regulations regarding spacing to WWKS, Cruz Bay, Virgin Islands and WEVI, Frederiksted, Virgin Islands.

Whether WWKS is operating on Channel 271A or Channel 267A from the sites designated by WWKS, there is a spacing greater than required. Also, Whether WEVI operates on either Channel 267A or 271A, there is spacing greater than required. A Section 73.215 Allocation Printout is part of this Technical Statement which demonstrates this separation. Because the clearance margin to WEVI on Channel 271A is greater than 50 KM, it did not show on the attached printout.
