Certification of Use of FCC Form 316

SJL of Pennsylvania, Inc., licensee of WICU-TV, Erie, PA, is 100% owned by SJL of California, L.P., a Delaware limited partnership. The sole general partner of SJL of California, L.P. is SJL of California, Inc., a Delaware corporation, and the sole limited partner of SJL of California, L.P. is SJL Communications, L.P., a Delaware limited partnership. The officers and directors of SJL of Pennsylvania, Inc. are George D. Lilly (Chairman/Director), Brian Lilly (President/Director), Robert D. McCurdy (Vice President/Treasurer/Director), Pamela Davis Heilman (Secretary/Director), Sandra G. Benton (Director) and Susan Banka (Assistant Secretary). SJL of California, Inc. is owned 100% by SJL Communications, Inc. The officers and directors of SJL of California, Inc. are George D. Lilly (Chairman/Director), Robert D. McCurdy (Vice President/Treasurer/Director), Pamela Davis Heilman (Secretary/Director) and Sandra G. Benton (President/Director). The officers and directors of SJL Communications, Inc. are the same as those of SJL California, Inc., with the addition of Richard B. Armfield, Jr. (Director).

The sole general partner of SJL Communications, L.P. is SJL Communications, Inc. and the attributable limited partners of SJL Communications, L.P. are SJL Partners, L.P., a Delaware limited partnership; George D. Lilly 1995 Family Trust; Richard B. Armfield, Jr.; Pamela Davis Heilman; Robert D. McCurdy; George D. Lilly; Carole A. Henery; Sandra G. Benton; Diana S. Crants; Weldon B. Paulsen and Lorraine E. Hansen. All other limited partners are insulated.

The general partners of SJL Partners, L.P. are the George D. Lilly 1997 Business Trust and SJL Broadcast Management Corp. The attributable limited partners of SJL Partners, L.P. are Richard

B. Armfield, Jr., Diana S. Crants, Carole A. Henery, Denise Hopkins, Lorraine E. Hansen, Robert D. McCurdy, Weldon B. Paulsen, George D. Lilly 1995 Family Trust and George D. Lilly. All other limited partners are insulated. The officers and directors of SJL Broadcast Management Corp. are George D. Lilly (President/Director), Robert D. McCurdy (Vice President/Treasurer/Director) and Pamela Davis Heilman (Secretary/Director).

SJL Broadcast Management Corp. is 100% owned by the George D. Lilly 1997 Business Trust. The stockholders of SJL Communications, Inc. are The George D. Lilly 1997 Business Trust (80.9%), Richard B. Armfield (10.79%), Robert D. McCurdy (6.74%) and Sandra G. Benton (1.57%).

Attached as Exhibit 2 – Attachment 1 is a current organizational diagram of SJL of Pennsylvania, Inc.

This application proposes a corporate restructuring whereby the license of WICU-TV will be assigned from SJL of Pennsylvania, Inc. to a new wholly-owned subsidiary, SJL of Pennsylvania License Subsidiary, LLC. SJL of Pennsylvania, Inc. will be the sole member of SJL of Pennsylvania License Subsidiary, LLC and Brian Lilly will be the Manager of SJL of Pennsylvania License Subsidiary, LLC. After the assignment, the officers and directors of SJL of Pennsylvania, Inc. will be George D. Lilly (Chairman/Director), Robert D. McCurdy (Vice President/Treasurer/Director), Pamela Davis Heilman (Secretary/Director), Brian Lilly (President/Director), Sandra G. Benton (Director) and Susan Banka (Assistant Secretary/Business Manager). See Exhibit 2 – Attachment 2 for proposed corporate restructured organizational diagram.

The assignment of license constitutes an assignment from a corporation to a wholly-owned subsidiary and therefore is pro forma in nature and is properly filed on FCC Form 316. See Section 73.3540(f)(5) of the Commission Rules.

No monetary consideration was given in connection with this transaction because it was an inter-company transaction.
