Application for Transfer of Control of WTVG(TV)

The Walt Disney Company is the direct parent of Disney Enterprises, Inc. which is the direct parent of ABC Enterprises, Inc., which in turn is the direct parent of ABC, Inc., which in turn is the direct parent of CC/ABC Acquisition IV, CC/ABC Acquisition V, and CC/ABC Acquisition VI. CC/ABC Acquisition V and CC/ABC Acquisition VI each hold 50% interest in WTVG Associates. WTVG Associates is the limited Partner and holds 20% interest in, and CC/ABC Acquisition IV is the General Partner and holds 80% interest in WTVG, Inc., the current licensee of WTVG(TV). The Walt Disney Company is a publicly held company and is the ultimate parent of both the licensee and the transferors in this application.
