In evaluating the proposed displacement for K69GO, an outgoing interference study was executed on the proposed parameters on channel 33(+) with an ERP of 45 KW. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference using the OET-69 Longley Rice methodology with a cell size of 1km and a 0.1km radial spacing, there was zero percent interference present found in each case when rounded to the nearest percent.
