

COMPLIANCE WITH MULTIPLE OWNERSHIP RULES

This application seeks the Commission's consent for the assignment of the licenses associated with 11 radio stations in 7 markets from Citadel Broadcasting Company to The Last Bastion Station Trust, LLC (the "Trustee"), as trustee under the Citadel Divestiture Trust.

The stations to be assigned are:

Neither the Trustee nor Elliot B. Evers, the sole member of the Trustee, has any attributable interest in any other radio station in these markets. As is demonstrated in the following Arbitron Metro methodology and contour-overlap methodology showings, the proposed assignments comply with the Commission's local radio ownership rule in each relevant market.

Albuquerque, NM Arbitron Metro

Upon consummation of the proposed transaction, Trustee will have an attributable interest in station KBZU(FM), Facility ID No. 48596, Albuquerque, New Mexico (Bernalillo County). Bernalillo County is included in the Albuquerque, New Mexico Metro.

As is shown on the attached "FCC Geographic Market Definition for Albuquerque, NM," generated using BIA Financial Network, Inc.'s Media Access Pro database, there are 44 licensed, full power commercial and noncommercial radio stations in the Albuquerque Metro.

The Commission's multiple ownership rule (47 C.F.R. § 73.3555(a)) provides that in a radio market with between 30 and 44 (inclusive) full-power, commercial and noncommercial radio stations, a person or single entity may have a cognizable interest in not more than 7 commercial radio stations in total and not more than 4 commercial stations in the same service.

Trustee will have an attributable interest in 1 FM station in the Albuquerque, NM Arbitron Metro, and therefore will comply with the local radio ownership limits.

Little Rock, AR Arbitron Metro

Upon consummation of the proposed transaction, Trustee will have an attributable interest in stations KPZK(AM), Facility ID No. 24150, Little Rock, Arkansas (Pulaski County); KVLO(FM), Facility ID No. 28114, Humnoke, Arkansas (Lonoke County); and KARN-FM, Facility ID No. 24151, Sheridan, Arkansas (Grant County). Pulaski and Lonoke Counties are included in the Little Rock, Arkansas Arbitron Metro. Grant County is not included in an Arbitron Metro; however, Station KARN-FM, which is licensed to a community located in Grant County, reports the Little Rock, Arkansas Metro as “home” market. Therefore, for Station KARN-FM, the local radio ownership showing is provided using both the Arbitron market methodology and the contour-overlap methodology.

As is shown on the attached “FCC Geographic Market Definition for Little Rock, AR,” generated using BIA Financial Network, Inc.’s Media Access Pro database, there are 41 licensed, full power commercial and noncommercial radio stations in the Little Rock Metro.

The Commission’s multiple ownership rule (47 C.F.R. § 73.3555(a)) provides that in a radio market with between 30 and 44 (inclusive) full-power, commercial and noncommercial radio stations, a person or single entity may have a cognizable interest in not more than 7 commercial radio stations in total and not more than 4 commercial stations in the same service.

Trustee will have an attributable interest in 3 FM stations in the Little Rock, AR Arbitron Metro, and therefore will comply with the local radio ownership limits.

As is shown on the attached contour analysis prepared by du Treil, Lundin and Rackley, Trustee’s ownership of station KARN-FM will comply with the Commission’s local radio ownership rule using the contour overlap methodology.

This radio multiple ownership analysis was prepared concerning the proposed ownership of radio stations in the Little Rock, Arkansas area. This analysis was prepared under the FCC interim contour analysis method.* Considering the stations to be acquired and all other radio stations attributable to the proponent in the region, the following stations were analyzed:

The principal community contours of all of these stations are depicted on a map included herein as Figure 1. The radio multiple ownership analysis considers only those stations with overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m

for FM stations). An ownership study was prepared in accordance with the Federal Communications Commission multiple ownership rules as outlined in Section 73.3555.

Radio Markets

The “radio market” applicable to common ownership of the subject stations is defined as the area encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned. As listed in the table below, there are three defined “radio markets” formed by the subject stations:

Count of Stations in Defined Markets

The number of radio stations in a “radio market” is determined by counting the operating stations that have principal community contours that intersect the principal community contours that define the radio market. Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area were employed in the count of stations. Commonly owned stations, other than those that form the market in question, were not considered in the count of stations in the defined markets. The results of the analysis are tabulated below:

Figure 2 is a tabulation of the radio stations identified in the defined radio markets. Only known licensed, operating stations were employed for the study. Distances to the AM coverage contours were predicted using the antenna patterns as identified in the Commission's AM database and the appropriate Ground Wave Field Strength versus Distance Graph described in Section 73.184 of the FCC Rules. Ground conductivity data were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method outlined in Section 73.313 of the FCC Rules. Terrain data were derived from the U.S.G.S. 3-second computer database for each of the FM stations using radials evenly-spaced every 5 degrees of azimuth.

Based on the above, it is concluded that the proposed combination of the stations to be owned complies with Section 73.3555(a) of the FCC Rules.



Oklahoma City, OK Arbitron Metro

Upon consummation of the proposed transaction, Trustee will have an attributable interest in stations WWLS-FM, Facility ID No. 6509, Bethany, Oklahoma (Oklahoma County); and KINB(FM), Facility ID No. 88376, Kingfisher, Oklahoma (Kingfisher County). Oklahoma County is included in the Oklahoma City, Oklahoma Arbitron Metro. Kingfisher County is not included in an Arbitron Metro; however, Station KINB(FM), which is licensed to a community located in Kingfisher County, reports the Oklahoma City, Oklahoma Metro as “home” market. Therefore, for Station KINB(FM), the local radio ownership showing is provided using both the Arbitron market methodology and the contour-overlap methodology.

As is shown on the attached “FCC Geographic Market Definition for Oklahoma City, OK,” generated using BIA Financial Network, Inc.’s Media Access Pro database, there are 41 licensed, full power commercial and noncommercial radio stations in the Oklahoma City Metro.

The Commission’s multiple ownership rule (47 C.F.R. § 73.3555(a)) provides that in a radio market with between 30 and 44 (inclusive) full-power, commercial and noncommercial radio stations, a person or single entity may have a cognizable interest in not more than 7 commercial radio stations in total and not more than 4 commercial stations in the same service.

Trustee will have an attributable interest in 2 FM stations in the Oklahoma City, OK Arbitron Metro, and therefore will comply with the local radio ownership limits.

As is shown on the attached contour analysis prepared by du Treil, Lundin and Rackley, Trustee’s ownership of station KINB(FM) will comply with the Commission’s local radio ownership rule using the contour overlap methodology.

This radio multiple ownership analysis was prepared concerning the proposed ownership of radio stations in the Oklahoma City, Oklahoma area. This analysis was prepared under the FCC interim contour analysis method.* Considering the stations to be acquired and all other radio stations attributable to the proponent in the region, the following stations were analyzed:

The principal community contours of all of these stations are depicted on a map included herein as Figure 1. The radio multiple ownership analysis considers only those stations with overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations). An ownership study was prepared in accordance with the Federal Communications Commission multiple ownership rules as outlined in Section 73.3555.

Radio Markets

The “radio market” applicable to common ownership of the subject stations is defined as the area encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned. As listed in the table below, there are two defined “radio markets” formed by the subject stations:

Count of Stations in Defined Markets

The number of radio stations in a “radio market” is determined by counting the operating stations that have principal community contours that intersect the principal community contours that define the radio market. Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area were employed in the count of stations. Commonly owned stations, other than those that form the market in question, were not considered in the count of stations in the defined markets. The results of the analysis are tabulated below:

Figure 2 is a tabulation of the radio stations identified in the defined radio markets. Only known licensed, operating stations were employed for the study. Distances to the AM coverage contours were predicted using the antenna patterns as identified in the Commission's AM database and the appropriate Ground Wave Field Strength versus Distance Graph described in Section 73.184 of the FCC Rules. Ground conductivity data were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method outlined in Section 73.313 of the FCC Rules. Terrain data were derived from the U.S.G.S. 3-second computer database for each of the FM stations using radials evenly-spaced every 5 degrees of azimuth.

Based on the above, it is concluded that the proposed combination of the stations to be owned complies with Section 73.3555(a) of the FCC Rules.



Upon consummation of the proposed transaction, Trustee will have an attributable interest in stations WCYI(FM), Facility ID No. 26389, Lewiston, Maine (Androscoggin County); and WCLZ(FM), Facility ID No. 56569, Brunswick, Maine (Cumberland County). Cumberland County is included in the Portland, Maine Arbitron Metro. Although Androscoggin County is included in the Lewiston-Auburn Arbitron Metro, WCYI(FM) reports the Portland Metro as “home” market, and therefore, for local radio ownership purposes, WCYI(FM) will be considered in both the Portland and the Lewiston-Auburn Metros.

As is shown on the attached “FCC Geographic Market Definition for Portland, ME,” generated using BIA Financial Network, Inc.’s Media Access Pro database, there are 30 licensed, full power commercial and noncommercial radio stations in the Portland Arbitron Metro. The Commission’s multiple ownership rule (47 C.F.R. § 73.3555(a)) provides that in a radio market with between 30 and 44 (inclusive) full-power, commercial and noncommercial radio stations, a person or single entity may have a cognizable interest in not more than 7 commercial radio stations in total and not more than 4 commercial stations in the same service.

Trustee will have an attributable interest in 2 FM stations in the Portland, ME Arbitron Metro, and therefore will comply with the local radio ownership limits in the Portland Metro.

As is shown on the attached “FCC Geographic Market Definition for Lewiston-Auburn, ME,” generated using BIA Financial Network, Inc.’s Media Access Pro database, there are 6 licensed, full power commercial and noncommercial radio stations in the Lewiston-Auburn Metro. The Commission’s multiple ownership rule (47 C.F.R. § 73.3555(a)) provides that in a radio market with 14 or fewer full-power, commercial and noncommercial radio stations, a person or single entity may have a cognizable interest in not more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service (provided that no person or single entity may have a cognizable interest in more than 50% of the full-power commercial and noncommercial radio stations in such market unless the combination of stations comprises not more than one AM and one FM station).

Trustee will have an attributable interest in 1 FM station in the Lewiston-Auburn, ME Arbitron Metro, and therefore will comply with the Commission’s multiple ownership rule in the Lewiston-Auburn Metro.
