Dear Ms. Dortch:

Edgewater Broadcasting, Inc. ("Edgewater"), permittee of FM translator station K284CM, Placerville, California, together with Lotus Sacramento Corp. ("LSC"), the licensee of KMJE(AM), hereby request a waiver (47 CFR §1.3 and §73.3598) of the construction deadline for the K284CM construction permit pursuant to Note 36 in the *First Report and Order, Further Notice of Proposed Rule Making and Notice of Inquiry* in MB Docket No. 13-249, *Revitalization of the AM Radio Service*, 30 FCC Rcd 12145 (2015). Note 36 states that waivers of the Auction 83 FM translator permit deadlines are "presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations."

K284CM has a permit that was granted as a result of the Auction 83 window filings (see BNPFT-20130830ASN), and the permit is scheduled to expire on January 16, 2017. Edgewater has separately filed a 250 mile window application (BMPFT-20160920AFP) to relocate K284CM in order to rebroadcast AM station KMJE, Olivehurst, California. Edgewater has a rebroadcast consent agreement with LSC, licensee of KMJE. Edgewater commits to promptly constructing and initiating operation of the translator once the pending assignment application and proposed 250 mile window relocation application are granted so that KMJE can be rebroadcast as contemplated in the AM Revitalization Order.
