In evaluating the proposed digital flash cut for K32FW FID 129373, an outgoing interference study was executed on the proposed design in the attached application using the OET-69 Longley Rice methodology. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference, there was zero percent interference present found in each case when rounded to the nearest whole percent.

Three Angels Broadcasting Network recognizes that the proposed move is more than 10km and requests a waiver on this point to move to the location where the rest of the LPTV stations are located.
