DIVERSITY SHOWING

Westminster was granted the construction permit ("Permit") for a new noncommercial educational FM station at Eastpoint, Florida, on the basis of points. It received two points for diversity and one point for superior coverage. See, *Memorandum Opinion and Order, MX Group 50, et al.* Released February 16, 2010. Bible Broadcasting Network, Inc. ("BBN") would be entitled to points for diversity and superior coverage as well. None of the consideration in this transaction is attributable to the acquisition of the Eastpoint construction permit.

BBN hereby certifies that there is no contour overlap between the station being acquired and any station in which BBN, its officers, and directors have attributable broadcast interests, and that this diversity of ownership will be maintained for at least 4 years of on-air operations. To ensure future compliance as board composition might change, this provision is contained within BBN's governing documents, copy attached as Attachment A.

There is no need to address best technical since, at this time, BBN plans to build according to original Permit. If a modification is sought in the future, BBN will provide in any future application for minor change evidence of continued compliance with the technical representations made by Westminster in obtaining the Permit.

Attached hereto as Attachment B is a map showing BBN's relevant attributable interests in the state of Florida, which depicts the 60 dBμ contour of the Permit and the 60 dBμ contours of BBN's noncommercial FM stations and non-fill-in FM translators. None of the 60 dBμ contours overlap or come within 10 miles of the 60 dBμ contour of the Permit. BBN has no attributable interest in either AM stations or TV stations in Florida. A copy of this information has been transmitted to Westminster Academy for inclusion in the Eastpoint public inspection file.

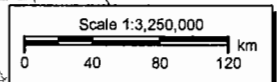
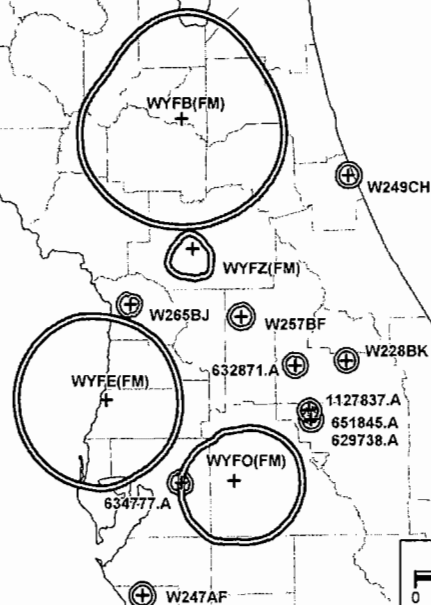
